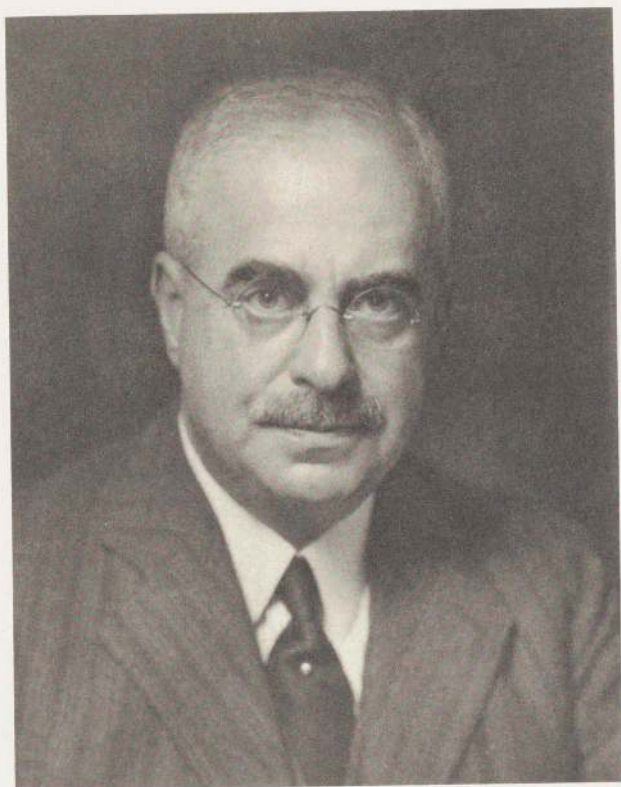

Foreword

Although Paul Sachs will be remembered for many things, during his life he was best known for his achievements as a director of the Fogg Museum. What made these achievements possible were his talents as a counselor, a teacher, a friend and an administrator, but especially his capacity to harmonize the diversity of his gifts. Collecting provided the focus. It requires discrimination, and this quality was the foundation of that good advice he gave so widely and so well. For some, teaching is based on the ordering of facts, for others, on the propounding of hypotheses. His was inspired by the true collector's passion for objects. But however intense, his love of works of art never ended with himself. It was always a means, first to achieve, then to convey understanding. Hence, rising as it did above mere personal predilection, this love of works of art could on the one hand provide a bond with his innumerable friends, and on the other illumine the central educational purpose of a University Art Museum.

Gradually and gracefully, over twenty years, Paul Sachs withdrew from the concerns to which he had devoted his life. Each relinquishment posed a challenge to those whose good fortune it was to take over the activities his wisdom had directed, his enthusiasm had made thrive, and his generosity had sustained. But from collecting and his collections he never retired. So, until the checklist which accompanies this catalogue was prepared, neither his family nor his closest professional associates were aware of the range of his artistic interests or the extent of his donations. Until the finest works of art he had collected were here for the first time put on display no one could grasp how sure and how profound was his perception of quality.

Yet to those who knew Paul Sachs even this exhibition and its catalogue will seem but inert records. To us he left a more vital legacy. His capacity to recognize and understand beauty, his determination to preserve and to make available that beauty, his gift to communicate and his delight in communicating that understanding, these qualities have created for us a fresh image of goodness and have established for all a new definition of greatness.

Introduction

When Paul J. Sachs arrived in Cambridge, in the early autumn of 1915, to take up his post as assistant director of the Fogg Museum, he had had no museum experience whatsoever. His appointment had been proposed and supported by that imaginative planner, Edward W. Forbes, who, in 1909, had succeeded Charles H. Moore as the museum's director. Mr. Forbes had called upon his somewhat younger colleague-to-be (there was a five-year difference of age between them) in New York and convinced the younger man that there was a place in Cambridge for which he was eminently qualified. Although not without qualms concerning those qualifications, Paul Sachs was tremendously excited by the prospect and eager to make the change.

Samuel Sachs reconciled himself to the inevitable and released the eldest of his three sons from his position as a partner in the family banking firm of Goldman Sachs. The elder Mr. Sachs had until then hoped that Paul would follow in his own footsteps.

It was with high hopes and tremendous anticipation of a full and different life that the thirty-seven-year-old ex-banker moved his devoted wife and three small daughters to Cambridge. These hopes were to be more than fulfilled.

If, in one sense, Paul Sachs had no precise professional training for the place he was to assume (one might ask who had at that point in our history), in another sense he had been preparing for it all his life. As a boy he had covered the walls of his room with reproductions. As a young man he had begun his print collection. During the years following his graduation from Harvard (Class of 1900), both in New York and on his business trips abroad, he had visited all the great public and private collections to which he could gain access. Saturdays, accompanied by Mrs. Sachs, he had haunted the dealers and any special art exhibitions which were open. Early in life he had become an avid art book and photograph collector.

When he received official confirmation from Harvard of his appointment, which was to begin in September, 1915, he spent the first half of that year abroad, chiefly in Italy, seeing and learning as much as he could before the fall term began.

His first year at Harvard was devoted solely to the museum, not to teaching. The following academic year, 1916-17, he gave his first fine arts lectures—at Wellesley where he had been appointed "Lecturer in Art." A Harvard appointment in the Department of Fine Arts quickly followed. In 1917 he was made an assistant professor. The double association, as a museum administrator and as a member of the Department of Fine Arts—he became a full professor in 1927 and chairman of the department in 1933 and associate director of the museum from 1923 until his retirement—continued until 1945. That year both men retired from the museum, but Mr. Sachs continued three years longer as Professor.

The exciting quality of Paul Sachs's teaching, his contagious enthusiasm, his instantaneous reaction to an object of quality, no matter of what school or place, and his capacity to make his students see and feel that quality, a long generation of former students knows without being told. We have spoken about it elsewhere, as we have spoken about his unique Museum Course and the influence that his discerning judgment of men and situations has had upon the museum profession throughout the United States ("Paul J. Sachs," *Art Journal*, Vol. xxv, No. 1, Fall 1965).

Some of his former students will remember his love of one school or one type of object, others will remember his tremendous enthusiasm for something else. Almost no one, except possibly Edward Forbes, will have suspected the real breadth of his taste. Few can have surmised the extent of his generosity, although day after day and year after year individual students were aware of it, as he welcomed them to his house, lent them his books, gave them letters of introduction, and in many cases anonymously helped to finance their studies or their travels.

The present exhibition is to honor his memory and demonstrate his generosity. The choice will show as well, it is hoped, something of the scope and quality of his collecting, the degree of his accomplishment, and the influence of his taste. Until preparations for it were begun, no complete list of his gifts had ever been prepared. In fact no count of his prints, his gifts in just one, but the most numerous, category had ever been taken. There was a good reason for this. While he was attached to the Fogg Museum, at his express command, no label bore his name, whether as lender or donor. Many an object, familiar, loved and famous, that has borne for decades a label such as that, for example, on the painting by

the Osservanza Master, *Christ in Limbo*, "Gift of a Friend of the Fogg" can now be known as a gift of Paul J. Sachs (Pl. 87).

His gifts to the museum began before his arrival in Cambridge. His first was prophetic in two ways, for it showed not only the quality of his taste but the category in which he was to achieve pre-eminent status, the graphic arts. That gift was the etching by Rembrandt *The Great Jewish Bride* (Pl. 94). He presented it to the Print Room in 1911, a year before he was appointed to the museum's Visiting Committee, and four years before he moved to Cambridge. Over the years his gifts of prints continued to flow in. Early he had reasoned that, with a good eye and a modest fortune—and he had deliberately chosen against a large fortune—a distinguished collection of prints could be made, prints by some of the greatest masters in the history of art. So he began slowly to acquire them, increasing his knowledge with each purchase. When he moved to Cambridge he was already a confirmed print man. He often also made gifts of fine prints to the Museum of Fine Arts in Boston.

For a number of years he gave what was known as the Print Course. Many of the prints he purchased after his move to Cambridge were acquired as examples for his students. One has only to scan the list at the end of the catalogue to see how wide he cast his net to haul in, from a diversity of European schools, the rare, the unusual and the significant things. For example, there are sixteen woodcuts by Cranach, six rare woodcuts of the Swiss artist Urs Graf, twenty prints by the great master Hans Holbein the Younger, the woodcuts of the charming German called the Master of the Celtis Illustrations, a large number of eighteenth-century French etchings, and, to bring the examples closer to home, twelve etchings by Edward Hopper. This is the barest sampling of his gifts of prints which in its total reaches the enormous figure of 2,012 items. The catholicity of taste shown in that total is even more astounding. He is proved a very enlightened collector of all periods of graphic art. His profound but modest and never-pedantic knowledge he enthusiastically shared, with never-ending courtesy, with other collectors, both neophytes and old hands. He made print collecting a rewarding field not only for himself but for all serious students or collectors who partook of his interest in a very specialized field.

From 1935 until 1955, he was often joined by another notable print collector, the Bostonian Russell Allen. W. G. Russell Allen (1882-1955)

was shy, learned and enlightened, with a passionate love and understanding of the various print media. The negotiations, never completed, for the acquisition of the Albertina Collection brought the two men close together in the autumn and winter of 1935. From then on, until Russell Allen's death twenty years later, the short Paul Sachs (five feet) and the tall Russell Allen (6 feet 4 inches) made a picturesque pair as, at home and abroad, they happily ventured forth together, in search of new graphic work of quality and significance.

On that trip to Italy undertaken in 1915, just before he assumed his duties as assistant director of the Fogg Museum, he had made a few outstanding acquisitions not in the print field. For example, he had bought a Greek Head (fourth century B.C.) in Rome, and the *Christ in Limbo*, mentioned above, in London. On his return to New York he had persuaded his father to purchase the unfinished Tintoretto *Allegory of Fidelity* (Pl. 90), as he later persuaded him to acquire the two Poussins, the *Holy Family* (Pl. 91) and the *Birth of Bacchus* (Pl. 92), three paintings which his mother later presented to the Fogg Museum in her husband's memory. They are included in the present exhibition because Paul Sachs chose them, anticipating that one day they would undoubtedly become a permanent part of the Fogg's collection. After 1915 paintings or sculpture of comparable quality and importance were, with a few notable exceptions, to be beyond his means.

In the early twenties his concern began to embrace the field of drawings as well as prints. His visits to Léon Bonnat in the latter's Paris studio and his presence at the Degas Sales where he marveled at the French officers in their light blue uniforms, briefly away from the front, bidding enthusiastically for the drawings as they came up, made deep impressions on him. He, too, in wartime Paris had wished to make an acquisition, this time neither a print nor a drawing. He saw a beautiful sculptured head in a dealer's window. He knew neither the dealer (although they later became warm friends) nor the school to which the head belonged, but he yearned to own it. Before he could assemble the funds to buy it, he was ordered to report at Rheims. When he returned to Paris the head was gone, sold he suspected "to the trade." The memory of it haunted him. He not only kept an eye out for it, but told Denman W. Ross about it and asked the latter also to be on the lookout. His supposition was correct. The Khmer Head turned up in the New York

market. This time, although the price was higher, he did not hesitate. He bought it (Pl. 80).

A few other paintings and sculptures he also bought in London at the close of the war, but gradually almost all his emphasis and enthusiasm was directed towards drawings by the old and modern masters. There can be no doubt that in this field he was the pace setter in the United States. The Vanderbilt drawings at the Metropolitan Museum and the Fairfax Murray drawings at the Morgan Library had both been acquired "en bloc." Every drawing that entered the Sachs Collection was individually and lovingly chosen, and selected with such passion and enthusiasm that a whole generation of private collectors and museum curators caught the infection and began to follow his example. Many new museum curators had been members of the Museum Class or had taken the Print Course. When they became active in museums of their own, often their first exhibition was of prints or drawings. They turned to Paul Sachs for loans, loans which were almost never refused.

Many of his friends were now trustees of art museums, newly founded or seeking new aims and new staff and they came to him for advice. He never failed to have ideas for development or suggestions for staff. He was one of the seven founders of the Museum of Modern Art. Alfred H. Barr, Jr., was his suggestion as its first director. William Lieberman, the Curator of Graphic Arts, had been his student. It was characteristic of PJS, as he was affectionately called, that a few days after that museum opened its doors in 1929, he should give it its first drawing, the *Portrait of Anna Peter* by George Grosz (Pl. 70), kindly lent to this exhibition (the only loan) by the Museum of Modern Art. The Trustees later presented him with a Degas drawing for the Fogg, a copy after a sixteenth-century French drawing, which had come to them in the Lillie Bliss Bequest. Happily a year before he died, the new print and drawing galleries at the Museum of Modern Art, named in his honor, were completed.

If, in the late thirties and early forties, his acquisitions diminished in number, it was because works of great quality were becoming harder and harder to find, and the increasing number of grandchildren were a greater and more joyous distraction.

These were the years that saw the preparation and publication of the Fogg catalogue of drawings, the *Pocket Book of Great Drawings* and, as late as 1954, *Modern Prints and Drawings*. They were also the years in

which he gradually withdrew from the tremendously active life he had followed for many years, when as a valued board member he had been influential in forming the plans and policies of many an organization.

The hundred objects reproduced in this catalogue, all but one his gift or bequest to the Fogg Museum, show him only as an art collector. He was a great collector and a connoisseur in two fields. One was briefly mentioned above: books relating to the Fine Arts. The other was friendship.

It has proved not feasible to count the books. About 4,000 came in one year at the peak of his giving, when he and Mrs. Sachs gave up that house which had been literally a small center of civilization: Shady Hill; but thousands had come before and thousands more came after that cresting wave. The last came as bequests with the closing of his apartment a few months ago.

When he returned to Cambridge after the First World War there were fewer than 500 photographs and less than 1,000 slides in the old Fogg. When the "new Fogg" opened in June 1927, a building his enthusiasm and vision and that of Mr. Forbes had helped to make a reality, there were nearly 20,000 slides and 50,000 photographs. The library grew in comparable numbers, helped not only by his gifts but the gifts of many others who had caught his fever, and the support of the University which had come to recognize the value of such an adjunct to a teaching institution. The fact that this year the slides have passed the 100,000 mark, the photographs are nearly to the 300,000 and the books in the now-combined Fogg and Harvard Fine Arts Library are up to the 100,000 figure indicates that what he saw well started has continued to grow.

Of his friendships it is impossible to write briefly. A glance at his choice of drawings can be revealing. In the selection of seventy-five drawings from five centuries there are only six pure landscapes. It was not that he disliked landscape. It was rather that he loved and was fascinated by people, not people *en masse* but individuals of all ranks, all nations, all callings. He could be held as spellbound by the life of the simple Gaelic-speaking gardener as he was by that of the most *arriviste* tycoon. Such was his warmth and interest that doors were eagerly opened to receive him whenever he traveled, whether in this country or abroad. But he was happiest receiving, with Mrs. Sachs, a congenial gathering of old

and tested companions in his own hospitable house, where the talk was intimate if widely ranging and the fare was distinguished.

It was the fall of 1928. The writer, fresh from a year of graduate study abroad, had been interviewed and accepted for her first and, as it turned out, her only post. As she rose to leave, Professor Sachs had a final word. "I shall *never*," he said (and he was quite as good as his word), "ask you what hours you are keeping or how you are spending your time. I shall assume that as long as you work for us, wherever you are and whatever you are doing, you are working for the good of the Fogg Museum." It was not until long afterwards that it suddenly dawned that what he had in fact given was not an admonition but an accurate description of his own *modus vivendi*.

Compilers' Note

In preparing this exhibition, every drawing was removed from its frame and re-examined. Every drawing has also been rephotographed. An attempt has been made to give thoroughly accurate descriptions of the media used. In those cases in which the description here given does not tally with that of the Mongan-Sachs Catalogue of 1940, this later one should be favored. Each drawing has been re-measured. In some cases, in the light of new information, titles have been changed. The new measurements and titles now officially supplant previous ones.

We have not repeated the bibliographical and exhibition references previously published but limited our entries to what has appeared since 1940, or in the case of those drawings which went to Europe in 1948, to what has appeared since then. There is a single exception, Friedrich Winkler's *Dürer* which was published in Berlin in 1939, but was not yet in this country when the first edition of the catalogue went to press.

References to loan exhibitions have been included only if there was a published catalogue. We have not counted check lists or mimeographed catalogues. Many of the drawings have been shown in places as widely scattered as Waterville, Maine, Mobile, Alabama, and Phoenix, Arizona, but the exhibitions of which they were part had no catalogues; therefore, they are not mentioned. The Lugt number is given only when the collector's mark actually appears on the drawing.

The number given each drawing will indicate whether it came to the Fogg Museum as a gift or as part of the bequest. All drawings bearing numbers beginning with 1965 are part of the bequest which Mr. Sachs wished to have known henceforth as the Meta and Paul J. Sachs Bequest.

No further letters of the alphabet series to which these two drawings belong have turned up since we discussed them in the 1940 catalogue. A letter A that clearly belongs with them is in the Ashmolean Museum, Oxford. Two drawings, cut at the sides in a fashion similar to these, are in the Lewis Randall Collection, Montreal. Experts still do not agree on the place of origin of the series. Dr. K. G. Boon (visit, 1959) suggested a date after 1360. Dr. Hanns Swarzenski believes that they come from Southeast Germany, not Bohemia (conversation, August 26, 1965).

The drawing has long borne an attribution to Gozzoli, but Berenson was not convinced that it was by that master himself. He found the contours a little dry and hard for that engaging and imaginative pictorial painter. He suggested Bartolommeo Caporali of Perugia as its possible author. Others continued to accept the traditional attribution. Recently (in 1958 and again in 1965), however, Philip Pouncey has rejected the Benozzo attribution, also ruling out the possibility that it is by either Caporali or Bonfigli, two Central Italian painters strongly influenced by the Florentine master's work in Umbria. He assigns it, however, to that region. The Fogg Museum received in the Loeser Bequest a sixteenth-century copy of this drawing (Mongan-Sachs Catalogue, no. 17).

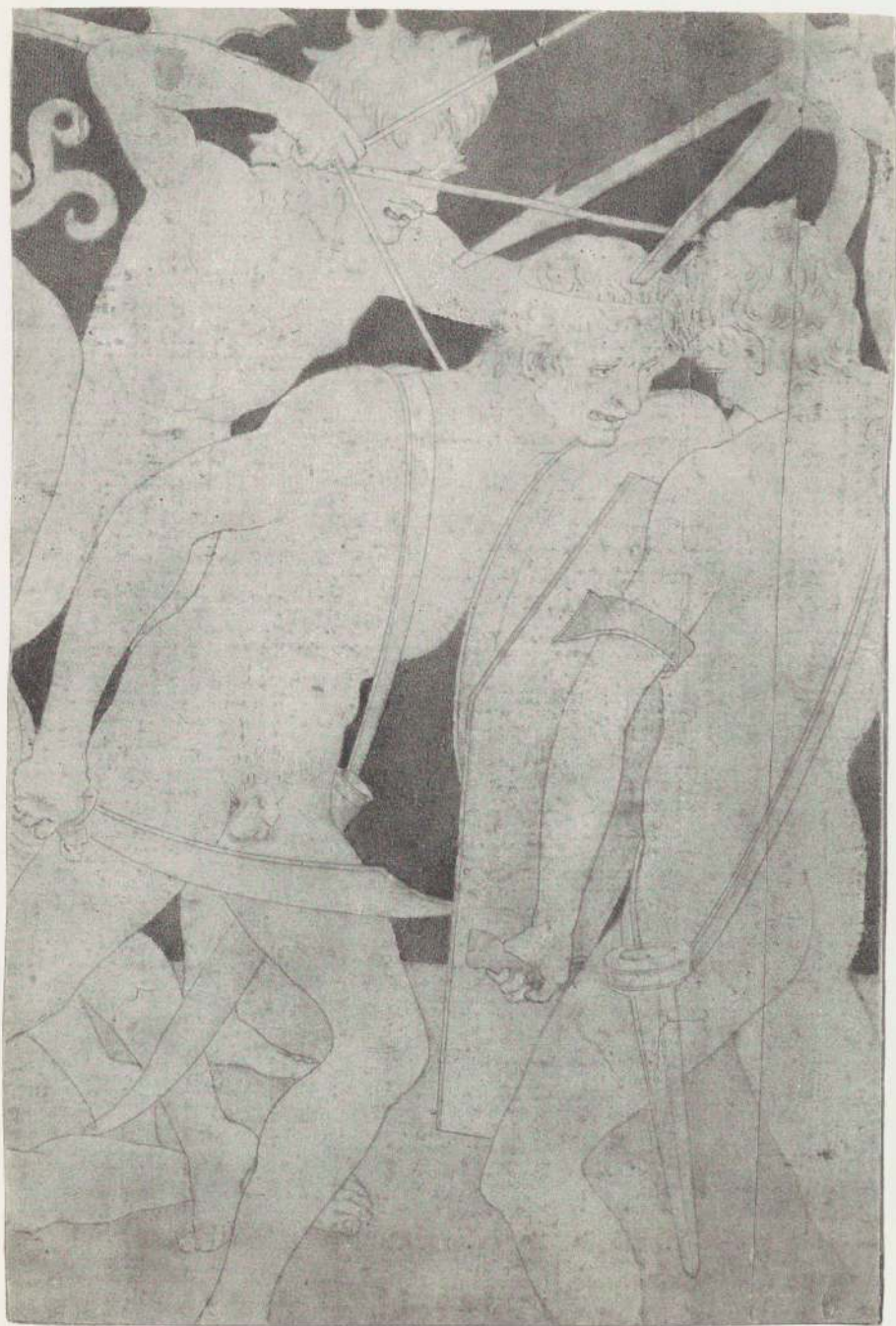

There seems little to add to the lengthy discussion of the puzzling meaning of this drawing and its significance for Florentine art. This has been explored in the Mongan-Sachs catalogue. An examination under high magnification of a copy of the engraving related to the drawing revealed that a deft restorer had made hitherto unsuspected additions in pen to the engraving. This suggested that a similar examination of the drawing should be made, and it was done. When the drawing was then compared to the facsimile of it, published while the drawing was still at Wilton House, it became clear that between the time that reproduction had been made and the time Paul Sachs acquired the drawing, it too had passed through the hands of a very clever and accomplished restorer. But the drawing, one of great rarity and historic importance, rightly remained one of the purchases of which Paul Sachs was most proud.

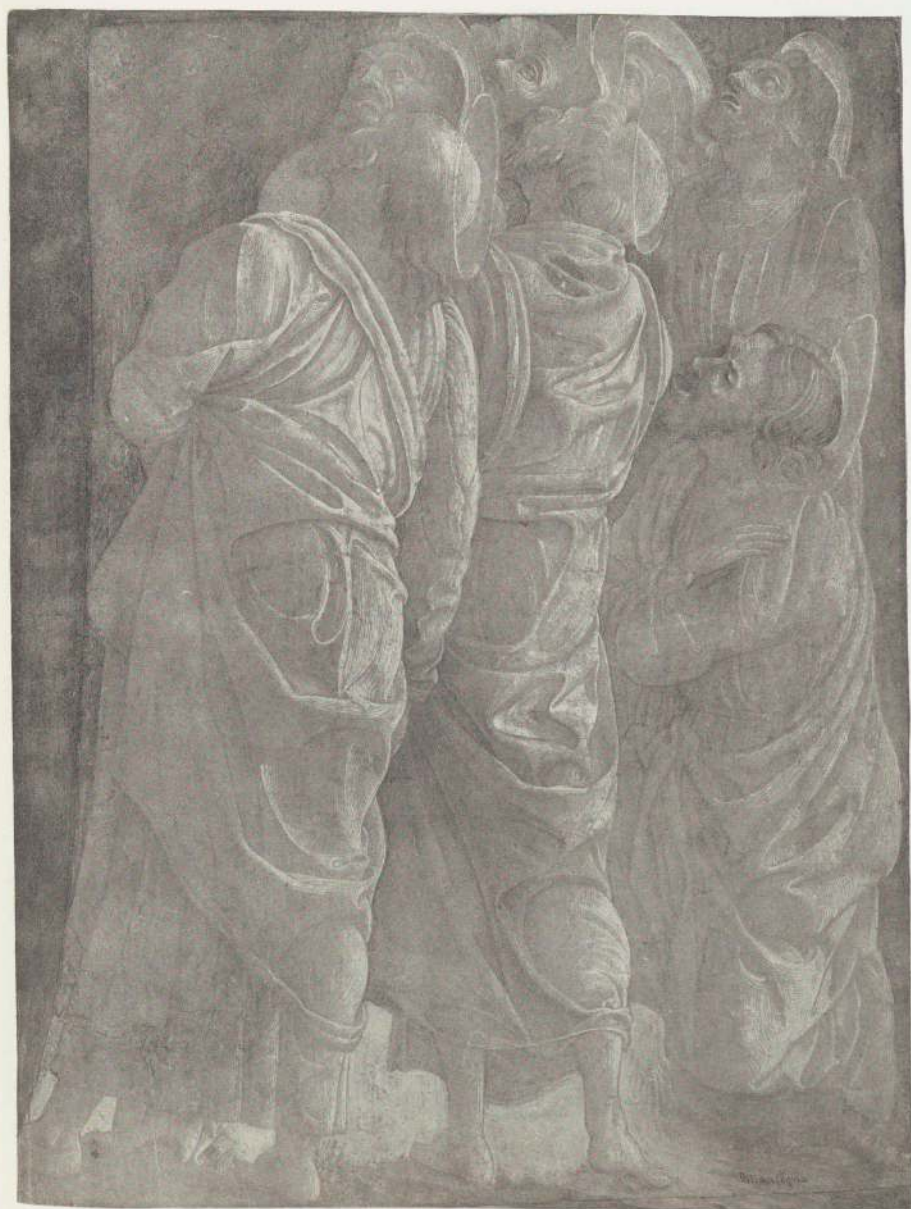

The drawing has long been known as *Seven Apostles*. In a paper submitted to the Department of Fine Arts in 1962, Robert Munman pointed out that actually there are eight apostles represented, as there are in the painting of 1464 in the Uffizi for which the drawing served as a *modello*. He reported extensively on the condition of the drawing, also noting that the figure of the Madonna can be discerned in close examination. The white at the bottom is a restoration. The recent cleaning of the Hampton Court *Triumph* has revealed that Mantegna handled his highlights there very much in the manner of those in this drawing.

The drawing, formerly erroneously described as in silverpoint, seems to have been done with a fine brush or soft pen. Berenson believed it contemporary with the Esther panels, that is between 1472 and 1480. Filippino often drew on paper prepared with different grounds, rose, violet, grey and blue; and generally on the colored grounds he used a silverpoint. This drawing would seem to be an exception.

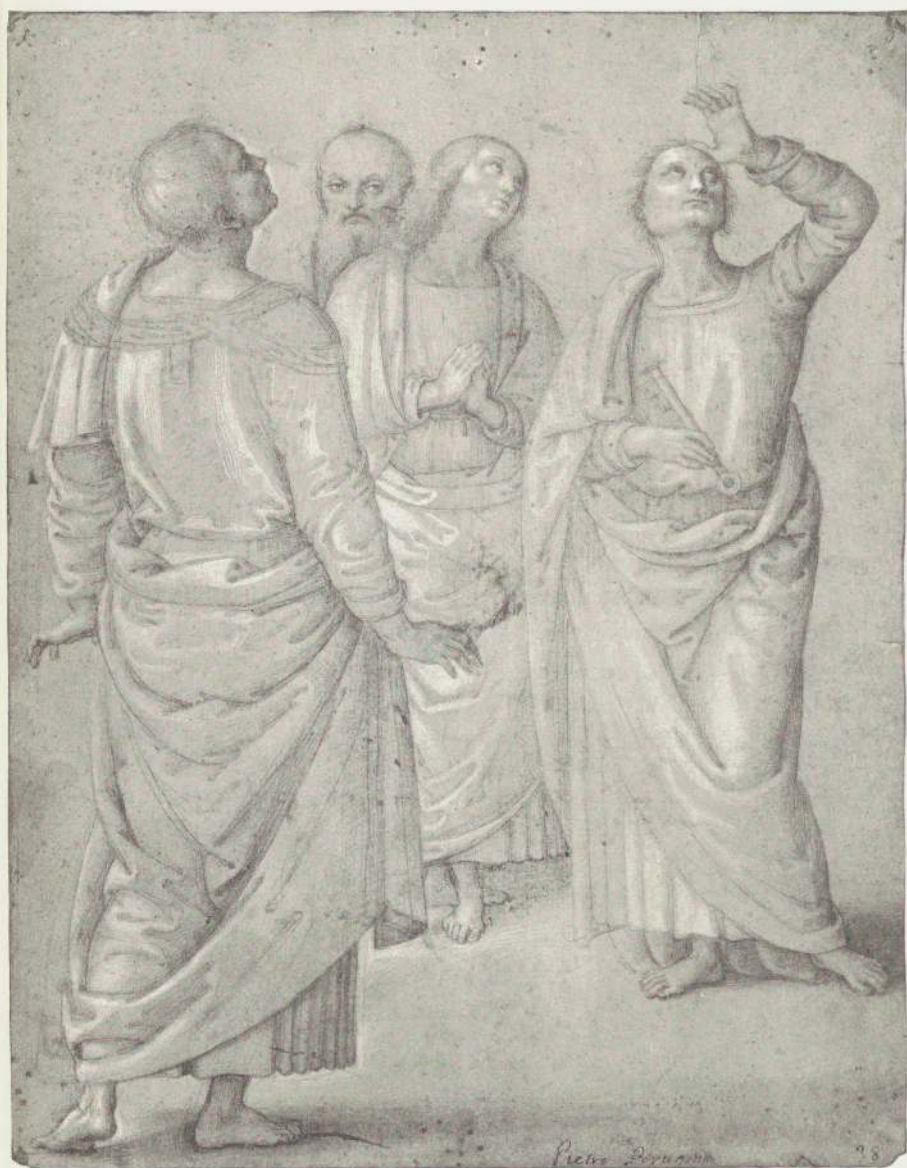

The drawing is a study for a large altarpiece of the Ascension, the central panel of which is now in the museum at Lyons. The altarpiece was commissioned on March 8, 1495, by the Benedictines of San Pietro, Perugia. The central part was finished in 1496. The painting was a great success and Perugino and his assistants repeated it at least four times. Probably the drawing remained in the workshop. Assistants and followers copied the whole group or separate figures. None of the copies or variants is as clearly, firmly and delicately drawn as the Sachs drawing.

The drawing, one of the very few which can with any confidence be attributed to Pinturicchio, is fascinating not only for its vitality and delicacy, but also because of its exotically dressed personalities and its suggestion of solemn ceremonial. Naturally it recalls Pinturicchio's bright and elaborate decorations for the Piccolomini Chapel, Siena, and the Borgia apartments at the Vatican. Since the lengthy discussion in the Mongan-Sachs catalogue, new data has not come to light.

In his early years in the monastery of San Marco, that is between 1500 and 1504, Fra Bartolommeo made countless drawings of the Madonna and Child, inventing an infinite number of charming variations on the theme. During those years a pen was his preferred tool. The scale of the drawings was small, the strokes light and rhythmical, the cross-hatchings deft and delicate, the mood intimate and gracious. Surviving drawings similar to this in mood and handling are preserved at Bayonne, Berlin, Florence, London and Windsor. In them is made visible Fra Bartolommeo's debt to Leonardo and the young Raphael's debt to him. A late copy of the drawing was formerly in the Brandegee Collection, Brookline.

When we prepared the entry for the Mongan-Sachs catalogue, we knew the Innsbruck *Adoration* only through a poor reproduction. An examination of the original (summer 1965) made it seem closer to the drawing in spirit and in design than we had previously thought. Schäufelein twice repeated the subject in woodcuts, once for an illustrated gospel of 1512 and once for a *Plenarium* printed in Basel in 1514. For the latter he made five large woodcut illustrations. Both the 1512 and the 1514 woodcuts show a composition in reverse to the drawing. The Balthasar of 1512 recalls the Balthasar of the drawing, and the elderly kneeling king with pointed beard of 1514 wears a similar robe, has an identical hat, and offers the Child a square box. This well-known and well-loved drawing by one of the greatest of all graphic artists is among the treasures of the museum. It is the single drawing which Paul Sachs discussed at length in his *Pocket Book* (see below). For many years it was also the drawing which Dr. Rosenberg chose to put before his graduate class in connoisseurship when, for the first time, they closely confronted an original work of art and were asked to consider its qualities and importance at every level: technical, iconographical, historical and aesthetic. Thus it is a drawing intimately known to a long generation of students. Winkler, who had not seen the original when he published his work on Dürer's drawings (see below), believed that possibly Dürer made the drawing on his journey to the Netherlands in 1521. He saw no reason to question the date, as Ephrussi had done. He was a little puzzled that such an important drawing had a history that went no further back than the middle of the nineteenth century. He suggested that possibly it was the *Entombment* in the Denon Sale in 1826, no. 607, noting that the entries in Denon's catalogue were summary and occasionally inaccurate. This suggestion we find reasonable.

Susanna, the daughter of Duke Albert the Wise and Kunigunda, the sister of Emperor Maximilian I, married first Casimir, Margrave of Kulmbach and a year after his death, that is in 1528, Otto Heinrich of Pfalz-Neuburg. She was described in an eighteenth-century inventory as "Dürer's great protectress." She was still the wife of Casimir when this portrait was drawn. At the beginning of this century the portrait was entitled Margaret of Hohenzollern. Kaiser Wilhelm II was about to acquire it as an ancestral portrait when the First World War broke out. He apparently did not know that Campbell Dodgson had provided a more accurate identification. Paul Sachs loved to recount how he had seen the drawing at Colnaghi's in London on his way to France in 1918, said he would like to have it, and had forgotten about it until, when the war was over, Colnaghi's had written to say they were holding it for him.

The drawing has suffered badly from the hand of Time. At some point it was remounted. Since the remounting is on wove paper, it was probably done in the nineteenth century. The inscription on the reverse of the mount by Wilhelm Koller is not to be lightly dismissed. Koller was, according to Lugt, a man of taste and an excellent connoisseur, not the type to create a legend. The fact that von Hütten did die in 1523 lends support to Koller's statement. It is generally agreed that the pen lines are later, but how much later it is impossible to say. Paul Sachs believed them original and, against strong opposition, maintained his opinion. The paper itself has been almost worn away and what remains has been strongly compressed. Much of the grey must also be a later addition. For many years the drawing was called *Portrait of a Leper*. Leprosy was long a generic term for skin diseases. More than one distinguished dermatologist in recent years has diagnosed the young man's ailment as a case of *impetigo contagioso*.

The drawing, probably the finished study for a decorative panel to be executed in grisaille or fresco, cannot be connected with any known surviving work. In style it seems to date after Primaticcio's return from Rome, where he had been sent by François I^{er} in 1540 after working eight years at Fontainebleau. He returned to France in the winter of 1541 with one hundred and thirty-three cases of works of art for the King. Primaticcio was then put in charge of executing all the royal commands for the decoration of Fontainebleau, as well as the restoration of antiquities, the casting of bronzes, and the manufacture of tapestries and of Limoges enamels. He held this post under four kings. There was so much to do that he generally contented himself with the making of drawings which were turned over to his assistants to be carried out in the various media for which they were intended.

Claude Gouffier, Master of the Horse to François I^{er} was Clouet's protector. This drawing must have been made about 1555, to judge by costume and style. An earlier drawing of him dating ca. 1543 is preserved at Chantilly (Moreau-Nélaton, *Les Clouets et leurs émules*, I, p. 53). A painted portrait at Versailles is about a decade later (Archives Photographiques 3225). There are a number of drawings which bear Hugford's numbering. They all represent court personages close to the household of Catherine dei Medici. Christine of Lorraine inherited the drawings from her godmother, the widowed queen, and carried them to Florence as part of her dowry when she went to Florence to marry the Grand Duke of Tuscany. How they got into Hugford's hands in the eighteenth century can only be surmised. He sold several to English noblemen making the grand tour and so they again traveled north of the Alps.

According to Carlo Ridolfi, the seventeenth-century historian, Veronese made many drawings on colored paper which, since they were done with great artistry and completeness, were as highly valued at the time as were his paintings. Several such drawings, of which this is one, survive. In its contrast of light and shadow within the three-color limit, the color of the paper, the wash, and the white highlights, it achieves effects quite close to those of the chiaroscuro prints so popular in the late sixteenth century. The Nebehay Catalogue noted that a copy of this drawing by Van Dyck is in the Albertina, Vienna. A variant, in the same technique, but with St. Joseph standing at the right and the Madonna facing three-quarters left, is in the British Museum.

The drawing is the preparatory drawing for the print of the same subject, a print accompanied by moralizing verses in Latin and Dutch. The drawing was unknown before 1953. Jakob Rosenberg dates it about 1600, placing it after the military prints of 1596-98, but before de Gheyn's freer work of the sixteen hundreds. In the figures and in its moralizing allegory, it reveals traces of mannerism; in its clean contours, the strict discipline of de Gheyn's master, Goltzius. The landscape, however, is freer, pointing toward the Baroque. The bowman shoots with his left hand because the scene will be reversed in the engraving. A later pen version, in de Gheyn's freer manner and without the landscape, is in the Berlin Print Room. The verses warn that the bowman, with the encouragement of the girl, takes aim against those swelled with pride and pomposity.

This handsome Baroque drawing has remained without an attribution because, although many names have been suggested, none seems to be beyond discussion. Dalton, its earliest known possessor, was librarian at Windsor and agent for George III from the latter's accession in 1760. In that capacity he made many journeys abroad. Possibly because the drawing lacked an attribution even then, it did not become part of the Royal Collection at Windsor. Dr. Pignatti (February, 1961) suggested Francesco Maffei (Vicenza ca. 1620–Padua 1660). He proposed that a comparison be made between our drawing and Maffei's preparatory study in the Albertina (Drawing Catalogue 1947, vi, no. 741) for the painting *St. Charles Borromeo with the Plague Stricken*.

The drawing is a study for the *Raising of the Cross* painted by Rubens between the summers of 1609 and 1610 and now in the Antwerp Cathedral. An oil sketch of the composition is in the Gallery of Art, Toronto. Another figure in the same pose, but not by the same hand came to the Fogg in the Winthrop Bequest. That drawing has also been attributed to Rubens, but it is not an attribution generally accepted.

The portrait is a study for one of the prints in van Dyck's *Iconography*, a series prepared between 1626, when van Dyck returned from Italy, and his departure, in 1632, for England. The engraving was made by Paul Pontius (Mauquoy-Hendrickx, no. 45). In the 1940 catalogue, we noted the existence of two grisailles. Since then we have learned of a third, in the collection of the Duke of Buccleugh at Boughton House. The Buccleugh grisaille (Courtauld neg. 1354/306) is more vigorous and lively than the Bonnat one; indeed, the latter seems probably a copy of it. In the grisailles, as in the engraving which is in the same direction, Coloma stands in front of a brocade curtain wearing dress armor, the silk sash of his rank across his chest, a marshal's baton in his left hand, his mailed right on a parapet. The hilt of his sword shows at the lower right. None of this does van Dyck depict, except to give a faint hint of the angle of the baton. Even the expression of the face is different. Here the noted Spaniard is less martial and severe in attitude, less the army commander, which he was, than the writer, diplomat and historian which he became.

For many years this drawing and its companion piece, a view of the same suit of armor from the front, given to the Fogg Museum in 1936 by Ambassador and Mrs. Robert Woods Bliss (Mongan-Sachs, no. 467), bore attributions to van Dyck that were unquestioned. In 1958, Dr. van Regteren Altena suggested that the two drawings might be by Paul de Vos. The Bliss drawing was requested and sent to the great van Dyck drawing exhibition in Antwerp in 1960. At that time, Horst Vey and Roger d'Hulst, the compilers of the catalogue, queried the attributions, suggesting the possibility that the drawing might perhaps be attributed to someone such as Paul de Vos, a specialist, they pointed out, in the painting of armor. They found the rendering rather plastic, uncharacteristic for van Dyck's more fluid line at that period, but did not altogether reject the drawing. They believed the armor itself to be of South German origin, made probably between 1620 and 1640. Other experts who visited the van Dyck exhibition saw no reason to question the traditional attribution.

Benesch identified the woman as Rembrandt's wife, Saskia, playing with their son, Rumbartus, and on the basis of this concluded "that the drawing was not done before 1636." However, Dr. Van Eeghen's archival research established that Rumbartus only lived two months (December 15, 1634–February 15, 1635) and since the child here is clearly older than two months, this attractive idea must be discarded. Judging upon the basis of style, the drawing is dated best in the late 1630's. The candle on the chair at the left, the layers of shade which transform the wicker chair into an open door leading into an illuminated room, and other chiaroscuro effects are additions of a later date. In the Hofstede de Groot Bequest, Rijksprentenkabinet, Amsterdam, there is a drawing of a similar subject and interior (Benesch 404).

Although the drawing is generally accepted as by Rembrandt himself, Benesch considers it an attributed work, or one by a gifted early pupil such as Lievens or Backer. He would date it in the early 1640's. Jakob Rosenberg, however, accepts it and associates it with Rembrandt's style of 1634-36. It seems possible (when one compares the quality of the pen line in the profile head of the woman with the strong hatchings in the washes beside the little girl's head) that Rembrandt returned, in the early forties, to an early drawing, as he frequently did, to rework the figures and enrich the plastic values of the heads.

The drawing probably represents a Netherlands shore. However, Hollar traveled and drew so constantly and in such a number of countries, it is impossible to be sure. He accompanied Thomas Howard, the First Earl of Arundel, as recording artist when Howard journeyed up the Rhine and down the Danube in 1637 on his way to the Imperial Court. The views made on that journey—many are preserved at Chatsworth and in the British Museum—have, like the views of London and of Tangiers, the place names written at the top by the artist. It is possible that this drawing once had such an inscription and that the top of the drawing has been cropped. There are several landscape drawings that are of approximately this width but they are generally somewhat higher, like the British Museum's *View of Whitehall*, which measures $3\frac{7}{8} \times 11\frac{3}{8}$ inches against the $1\frac{3}{4} \times 11\frac{7}{8}$ inches of this drawing. Hollar was again in the Lowlands in 1644 when, sharing the ill-fortunes of the Royalists, he escaped to Antwerp.

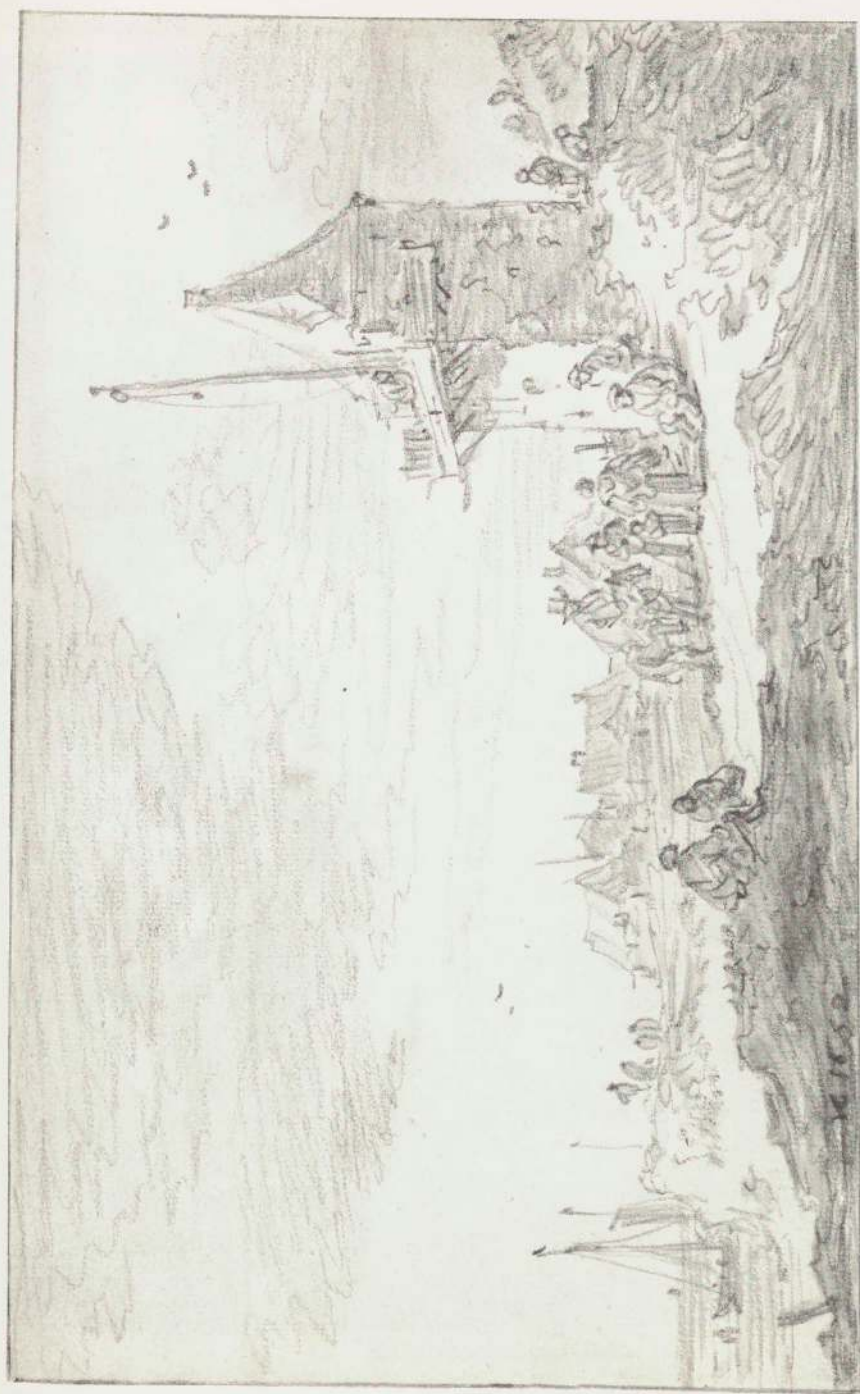

Dr. Hans Ulrich Beck of Munich is currently preparing a new catalogue-*raisonné* of Van Goyen's *oeuvre*. In a letter (December 14, 1964) he wrote that he believed the drawing was in a sale at Amsterdam, November 6, 1912, no. 108. It was bought by Gutekunst. This information seems confirmed by a pen notation on the back of the original frame "Bought in 1912." 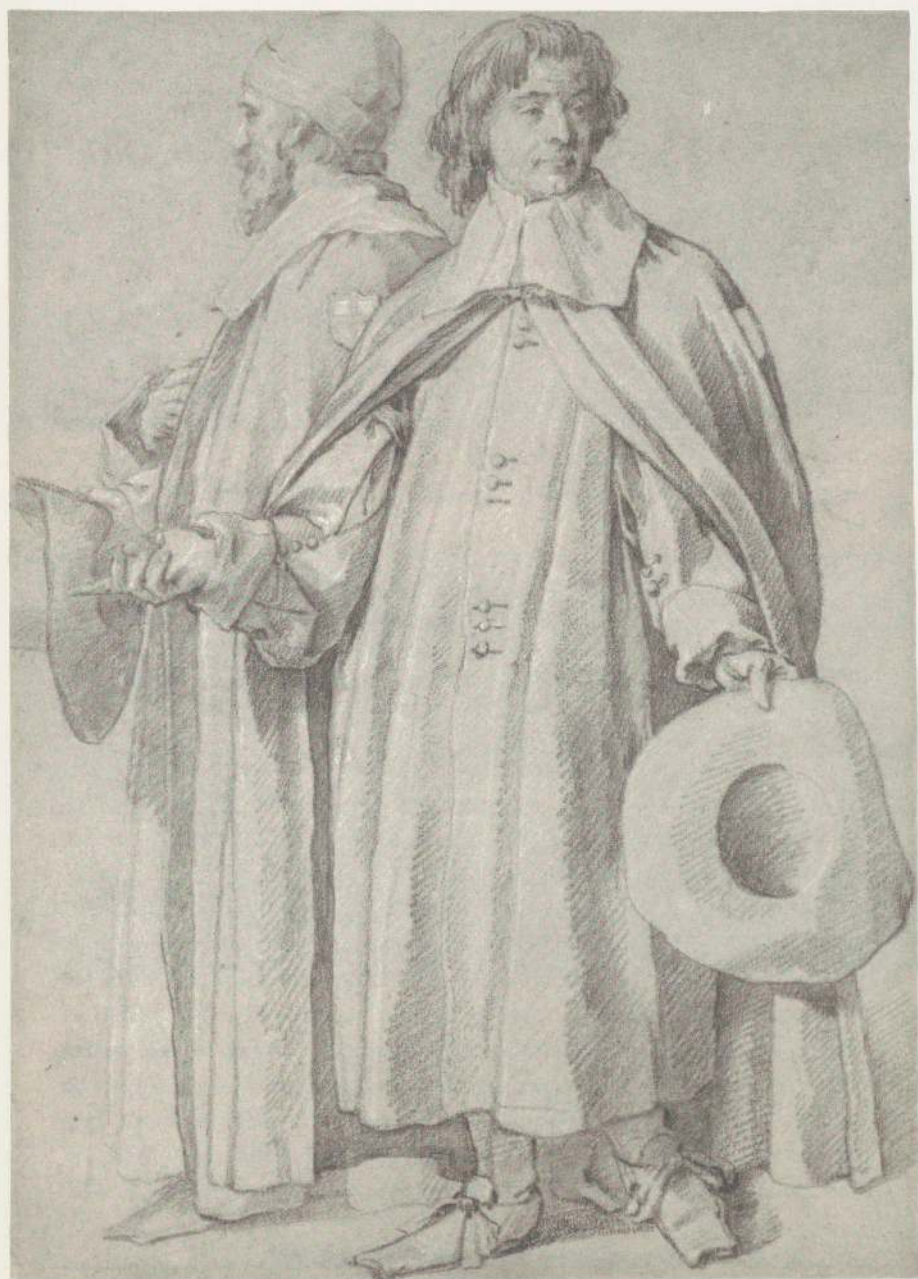

The drawing is one of a series of which at least thirty are now known. Sixteen are in the British Museum, the others in various public and private collections in Europe and America (see British Museum Catalogue, p. 409). Several of the British Museum drawings have been reworked "with oil-charcoal," a fate the Sachs drawing has happily escaped. It is not known for what purpose they were made, but it has been suggested that they were preliminary studies for a wall decoration for the Banqueting House at Whitehall, originally planned by Van Dyck. Lely owned Van Dyck's original oil sketch for a Garter Procession. Edward Croft-Murray and Paul Hulton (see below) also refer to a description of 1767 of a gallery at Burford House (the Duke of St. Albans) where there were represented the Knights of the Garter, all whole lengths done by Van Dyck and Sir Peter Lely. These pictures have disappeared. All the figures in the known drawings are connected with the ceremonies of the Order of the Garter on St. George's Day, April 23. Because of certain personages represented, the drawings must have been made between 1663 and 1671. The drawings were not in the vast and important sale of Lely's drawings after his death. The Poor Knights of Windsor were soldiers without fortune who had served the king, were pensioned by him, and lived in apartments at Windsor Castle.

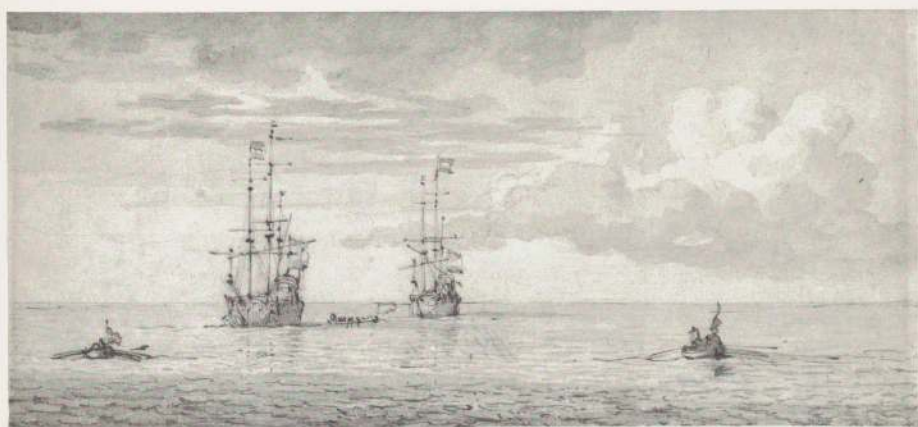

The drawings seem in style and size to be a pair, but the horizon line is not at the same height, nor, as their provenance shows, have they always been together. From 1677 to 1685 Willem the Younger was employed by Charles II in England. After Charles's death, James II pensioned him. In 1686 he visited Amsterdam. These drawings were probably made at that time, for the ships are flying Dutch flags. M. S. Robinson (*Van de Velde Drawings in the National Maritime Museum* [Greenwich], Cambridge, 1958, p. 23) has written: "To the period of the Younger's visit to Holland in 1686 belong a number of sketches in pen and brown ink with light grey wash mostly portraits of ships and yachts. This group is distinguishable from the drawings of about 1700 by the more modest use of the pen, rather as a strengthening to the wash instead of the wash being used to accentuate and fill out the pen-work."

Watteau filled his notebooks with studies of all kinds, copies from the old masters, nude figures, heads, hands, feet, soldiers, actors, children, animals and landscapes. He turned to these when he was ready to make a painting and chose from the repertory of his sketchbooks what he needed for his contemplated composition. The boy in the straw hat on this page stands behind the two seated children in the painting, formerly at Potsdam, *Iris, c'est de bonne heure avoir l'air à la danse*, a painting bought by Frederick II. The drawing for the head of the woman appears again in a sheet of studies in the Louvre (Parker-Mathey, no. 720). This drawing, which shows Watteau at the peak of his powers, probably was made about 1717-18.

The drawing is a preliminary study for a painting, *Venus and Mercury Instructing Cupid*, one of a series of over-door decorations which Boucher painted for the hôtel of Comte de Langonnay in the rue de Varennes. The painting, signed and dated 1738, is now in the Los Angeles County Museum. The drawing, with its rich and rhythmical line, is one of the most assured and graceful of Boucher's many drawings of the nude. In its pose and elegance and in the accents, especially those of the profile and the dimpled hands, there is still discernible Boucher's debt to Watteau.

Clodion, the most gifted of a family of decorator-sculptors, was a prolific artist. Vases, bas-reliefs, plaquettes, above all terra cotta statuettes came from his hand. Many survive so that his style is not unfamiliar, but although a portfolio of drawings was listed in the inventory of his possessions made after his death, his drawings are rare. His work, in its feminine grace and delicacy, is a plastic equivalent of Boucher's painting. As one would expect of a sculptor, in his drawings the movement is in three dimensions, circling constantly through the figure.

Edgar Munhall was the first to notice that the drawing is a preparatory study for Greuze's frontispiece to Mme. Benoit's moralizing tale *Sophronie*. Greuze's design for that little-known illustration was executed in 1768. It was engraved by Moreau le Jeune and published a year later. In the printed version, as one would expect, the figure appears in reverse to the young man in the sketch. The drawing is, as Mr. Munhall points out, much livelier and more expressive than the engraving. Greuze had not exhibited in the Salon of 1767; therefore, his incursion into the field of illustration may have been an attempt to keep his name before the public. He made another illustration the following year for de Souvigny's *La Rosière* or *La Fête de Salency*. His third and last venture into book illustration was a drawing made for the Baskerville edition of Ariosto's *Orlando furioso* of 1773 (Martin, no. 409).

The drawing probably dates from the early 1740's when Tiepolo was at the height of his powers, loaded with commissions both sacred and profane, his never-idle hand inventing an endless variety of scenes and figures. His drawings have brilliance, elegance, ease and economy that have remained unmatched. In this drawing there are echoes of Bellini and Veronese, but more movement in the figures and a more spirited play of light and shadow than the sixteenth century would have known. There are two other variants of the drawing known, one in Berlin (reprod. von Hadeln, *Die Handzeichnungen von G. B. Tiepolo*, Munich, 1927, I, pl. 42); the other was in the collection of Paul Wallraf (formerly Orloff, see below). There is a fourth related drawing in the Uffizi and a fifth in the de Courcelles Collection, Paris.

The drawing is similar in style to some other drawings of Piranesi's early years in Rome, that is to those made between 1745-50. The echoes of his Venetian training have not yet faded. Elements from Roman antiquity are combined to make a fanciful but powerful scene.

The view represents the left half of a wide panorama of the Bacino di San Marco. The right half, which is in the National Gallery of Canada, Ottawa, shows the Salute, the Dogana and the entrance to the Grand Canal. Apparently the Sachs drawing at one time had, like the Ottawa drawing, an empty expanse of water in the foreground. J. Byam Shaw suggests that the two drawings and a third, which carried the view of the end of the Giudecca at the left, were made by Guardi from a boat in the Bacino and used by him in preparing somewhat later the large ($13\frac{3}{4} \times 26\frac{5}{8}$ in.) and extensive panorama in the collection of Lady Catherine Ashburnham, Battle, Sussex. The Ottawa drawing was dated in the 1965 Guardi Exhibition "after 1775," a date that should hold as well for the Sachs drawing.

This drawing was one of a series of one hundred and four devoted to the life and death of Punchinello. The artist entitled the series "Divertimento per ragazzi." It was kept together until after the First World War. Before being broken up, the complete series was shown in the Musée des Arts Decoratifs, Paris, in 1921. This drawing seems to have been no. 22 of the series. This particular scene repeats with some variations a scene the artist had painted on the walls of the Villa Zianigo, a villa his father bought after their return from Würzburg. The wall decoration, transferred some years ago to the Cà Rezzonico, Venice, is dated 1793. The drawing would seem to date from somewhat later, perhaps at the turn of the century.

Goya numbered the Sachs drawing "49." Eleanor Sayre (see below) has traced at least twenty-four of the drawings which were, in what has come to be known as "The Black-Bordered Album," the album to which the Sachs drawing and another in the Winthrop Bequest clearly belong. She agrees with the dating, given previously, of about 1805, but does not rule out the possibility that the album may have been made even a decade later. When the Metropolitan Museum acquired their two black-bordered drawings and they were published by Henry Wehle, he noted that their drawings had once been mounted on coarse pink paper, vestiges of which remained. Vestiges of pink paper also were found on the Sachs drawing. What each drawing meant is not known. The mystery will probably remain until more turn up. We are indebted to Dr. Edith F. Helman for a corrected reading of the handwriting.

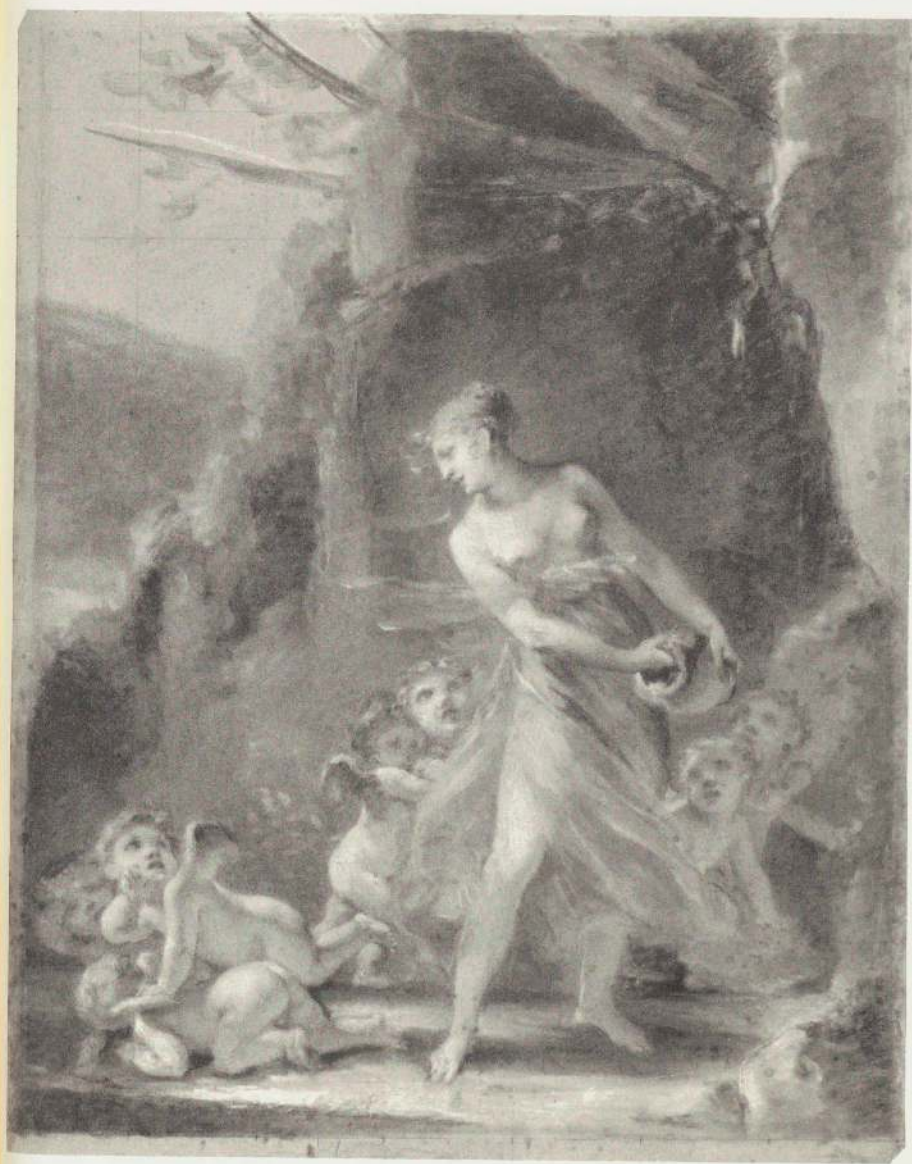

In addition to this drawing and the oil sketch in the Louvre (758A), M. Guiffrey lists seven other studies all made in preparation for the painting which Constance Meyer, Prud'hon's pupil, exhibited in the Salon of 1812. The academic sketch of a male nude recently uncovered on the verso of the sheet is one of many done by Prud'hon in his later years when he made studies after the model in the studio of another pupil, Trezel. Only rarely do these studies relate to his paintings or prints.

We are keeping the title originally given to the drawing in spite of the reappearance, after a hundred years, of the painting to which it is so clearly related. That painting, entitled *Fisherman at Sunset*, Huntington Hartford Gallery of Modern Art, New York, turned up in Europe in 1959 (Sale, Charpentier Gallery, Paris, December 3, 1959, no. 52). Specialists then recalled Clément's reference to such a scene. A sheet of three sketches formerly in the collection of Pierre Dubaut and a sheet of studies with six horizontal rows of studies of men pulling a boat (formerly in an album that belonged to David d'Angers, present whereabouts unknown) are, like our drawing, indubitably related to the painting. Clément wrote that such a landscape painting hung in Géricault's studio while he was at work on the *Raft of the Medusa*. The links are strong between the figure studies for the *Raft*, the Fualdès series, and the detail studies of the straining figures who appear also in the Sachs drawing, so there seems reason to place the date of the Sachs drawing somewhat later than we did before, that is to consider it a work of about 1817-18.

Joseph, a familiar model in the Paris ateliers of the time, posed for Géricault wearing a costume that the artist, who had a variety of North African costumes in his studio, assembled for him. The exotic clothing is but the point of departure for the dramatic presentation, the bold chiaroscuro and the strong sense of physical power held in equilibrium on the verge of action. Although not dated, the drawing was undoubtedly made not between 1820-24 when Clément dated it, but ca. 1817-18 when Géricault was at work on the *Raft of the Medusa*, using Joseph often as a model.

The Hayard family were friends of Ingres in Rome. He drew this exquisite portrait about 1812. Three years later he made two other drawings of the Hayard family, Mme. Hayard with her daughter, Caroline, which came to the Fogg Museum in the Winthrop Bequest in 1943, and Monsieur Hayard with their elder daughter Marguerite (Private Collection). Marguerite became Mme. Félix Duban. Ingres drew her portrait again in 1841, an indication that the friendship remained strong. The Sachs drawing passed from Marguerite to Caroline, who became Mme. Flachéron.

A study for the painting *The Martyrdom of St. Symphorien*, commissioned by the government in 1826 at the request of the Bishop of Autun, who wished a replacement for the Fra Bartolommeo altarpiece that had been taken to Paris during the Revolution. The Bishop selected the subject, choosing a local martyr. Ingres struggled with the painting. He did not finish it until 1834. When it was then severely criticized, Ingres requested and received the post of Director of the French Academy in Rome. There are more than two hundred and fifty studies for the painting at Montauban. There is another study for the *Crouching Youth* in the Bonnat Museum, Bayonne, and a very fine page, with drawings on both sides, in the Nelson Gallery, Kansas City. The Fogg received in the Winthrop Bequest two oil sketches for the painting and a later working drawing which is squared, perhaps for the engraver.

Mme. d'Haussonville (1818-82), born Louise de Broglie, was the granddaughter of Mme. de Staël and the great-granddaughter of Joseph Necker. In 1836 she married the Vicomte Othenin d'Haussonville, then Secretary to Ambassador Alquier, later Deputy, Senator, historian, and member of the French Academy. In Rome as a young man, Ingres had been commissioned by Alquier, then the Ambassador to the Holy See, to paint the now-famous *Portrait of Mme. Devauçay*. In 1842 Ingres accepted the commission to paint the portrait of the lively Vicomtesse. He did a preliminary oil sketch that year, but he abandoned his first plan. It was four years, after many sketches and sittings, trials and tempers, before the portrait, now in the Frick Collection, was brought to a triumphant finish. In this study the pose is very close to that of the painted portrait, but there is a certain informality, in both dress and mood, that brings her closer to the observer.

In 1832 Delacroix painted a portrait of Villot now in the National Museum, Prague (Venice Biennale, 1956, and Louvre Exposition, 1963, no. 151 bis). A year later he made a reduced copy which belonged to Villot's son. In 1838 he made another portrait described in the Louvre catalogue as "de face" and "inachevé." The Sachs drawing may be related to the latter; Villot is represented "de face" and as somewhat older than in the Prague portrait of 1832-33. The Sachs drawing also remained in Delacroix's studio until after the artist's death. Frédéric Villot, an intimate friend of Delacroix from the time that they both were young, was made Curator of Paintings at the Louvre on February 24, 1848. It was he who initiated a new hanging of the paintings, a more modern series of catalogues, and a scientific study of conservation and restoration. Yet, just when the friendship between artist and critic might have grown deeper, it suddenly cooled to superficial politeness. Denys Darcy (1823-1904) was the author of the Delacroix tomb in Père Lachaise Cemetery. Lugt supposes that at the time he designed the tomb he was given a batch of Delacroix's drawings (the stamp is to be found only on Delacroix drawings). His daughter inherited the drawings and her daughter sold them (one hundred and sixty-five sheets) to Cailac, the Paris dealer. In 1937 Maurice Gobin had a number of them, including this one, which Paul J. Sachs then acquired.

René Huyghe (*Delacroix, ou le combat solitaire*, Paris, 1964, p. 496) points out that the theme of struggle is fundamental in Delacroix, whether between an animal and its prey, a wild beast against a wild beast, a man against a man, or a man against a wild beast. Traditionally the animal here has been called a panther, but it could as well be a tiger. The Minneapolis catalogue points out that the Arab has his sword in his left hand and suggests that Delacroix may have copied an engraving which reversed a painted composition.

Corot sketched and painted Mount Soracte many times in the two successive summers of 1826 and 1827 when he went on trips into the countryside around Rome. Among the surviving drawings (Robaut lists more than twenty made at Cività Castellana) there is none which surpasses this drawing in nobility of conception or vibrancy of atmosphere. A painting of 1827 from a slightly different viewpoint was acquired recently by the Ny Carlsberg Glyptotek (see reference below). Another belonged to Daubigny, a gift of the artist (Robaut, no. 125). Soracte, the mountain which rises majestically out of the Campagna north of Rome, also gave inspiration to Horace, Virgil and Byron.

The identification of Henry Leroy (and the first name ends with the English "y" not the French "i") was made in a letter signed "Laure Henry Leroy, 2 Janvier 1914" which was on the reverse of the frame. We have not found the full name in the Corot literature, but there seems to be no reason to doubt its accuracy. Corot sketched the children of relatives and friends many times. In the Mongan-Sachs catalogue we dated the drawing about 1835. Further study has led us to believe, because of its plastic incisive qualities and the manner in which the figure is detached from its background, that it should be placed somewhat later, perhaps as late as 1845-50, when he did the portraits of the children of his former patron, Édouard Delalain (Robaut, nos. 595 and 596). For Paul Sachs this was "a drawing in which there is a complete absence of any calligraphic trick, a drawing which renders a mood miraculously."

Marguerite was the Sensier's only surviving child. After her father's death, she inherited his large collection of Millet drawings, prints and pastels. As Mme. Duhamel, she evicted Millet's widow from the Barbizon house where the painter and his family had lived for almost thirty years. In the Louvre there is a quick sketch from life (Louvre 10620) which shows a woman holding on her lap a baby in the same dress and position as in this drawing. One is led to conclude that Millet intended to make a portrait of Mme. Sensier holding Marguerite. (This drawing probably dates from ca. 1866.)

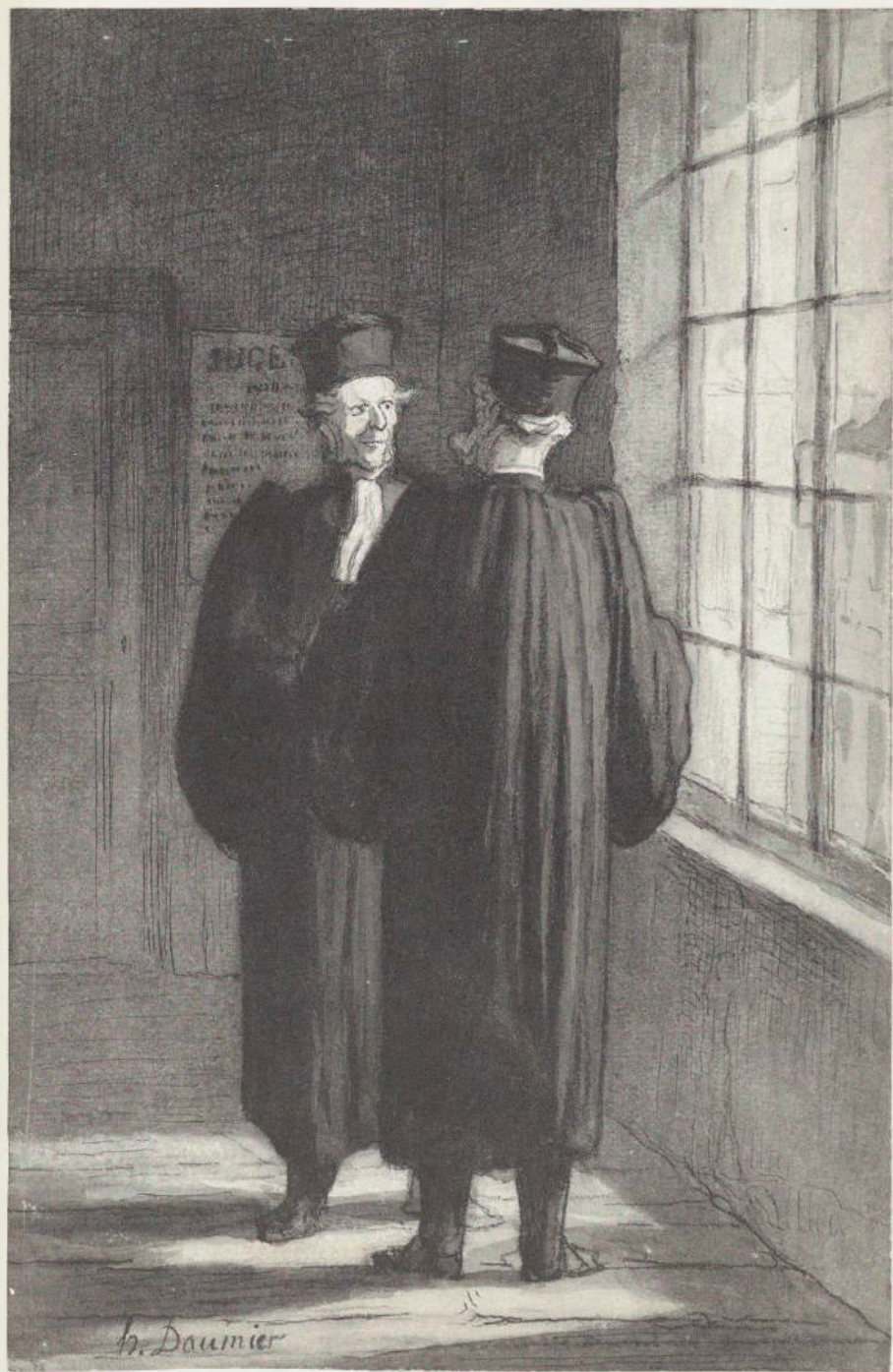

Two lithographs, both entitled *Le Café* (Marcel Guérin, *L'Oeuvre Gravé de Manet*, Paris, 1944, nos. 80 and 81), repeat the scene of the drawing but with some changes in the position of the figures and with the addition of mirror reflections in the left background. The lithograph measures $10\frac{1}{2} \times 13\frac{7}{8}$, that part of the drawing revealed by the window of the mat, $8\frac{7}{8} \times 11\frac{5}{8}$. A note on the back of the frame says that the drawing had once belonged to the art critic Castagnary and that Manet had represented himself in the drawing in the standing, bearded man, adding that there is little doubt that it was done in the Café Nouvelle Athènes. John Rewald (conversation), who doubts that Manet represented himself, believes that the Café is more probably the Café Guerbois, noting that Manet and his friends did not gather at the Nouvelle Athènes until about 1872. Alain de Leiris' *The Drawings of Edouard Manet* (Ph.D. thesis, Harvard, 1957, no. 230) notes that the bold pen line defines each object and also interprets the light, achieving through the latter a new kind of unity in the absence of a dramatic focus.

The drawing is a study for the portrait *Femme en robe noire*, in the collection of Jacques Lindon, New York (Lemoisne, no. 108). There is a separate study of the head in the Clark Art Institute, Williamstown, which is signed and dated in pencil at top right: Degas/1863, and at the bottom, annotated: Mme. Jules Bertin [*sic*]. The Bibliothèque Nationale has a sketchbook (Carnet 7) with studies of the hands. The date on the Clark drawing is probably also the date of the more complete Sachs drawing. Which reading is correct, that recorded on the Sachs drawing, which is clearly in the artist's own hand, or the annotation on the Clark drawing with the more common name "Bertin" is not yet known. In any event, the Sachs drawing is one of the most subtle and beautiful of the drawings which Degas made while still in his twenties. It shows clearly his debt to Ingres, and to the Quattrocento Italians whom he had studied assiduously in his early visits to Italy.

The drawing is a study for the central figure in *La classe de danse*, Camondo Collection, Louvre (Lemoisne, no. 341), a figure which appears also in the background of three versions of the *Repétition d'un ballet sur la scène*, one in the Louvre and two in the Havemeyer Collection, Metropolitan Museum (Lemoisne nos. 340, 400 and 498). Another drawing in the Rotterdam Museum, sometimes identified as the same model, is inscribed by Degas *Josephine Gaujelin autrefois danseuse à l'Opera*. She is the dancer whose painted portrait by Degas is in the Isabella Stewart Gardner Museum, Boston. The Sachs drawing is not stamped with the atelier red stamp but is signed by the artist, probably at the same time that he signed the Joyant facsimile. Lillian Browse gives an exact technical ballet title *Danseuse en Quatrième Dernière, Pointe Tendue*. She does not accept the identification of the dancer as Josephine Gaujelin. The same dancer is seen in the same position, but from a different angle, in the Camondo, *Classe de Danse de M. Merante* (Lemoisne, no. 298) and the Metropolitan Museum's *Leçon de danse* (Lemoisne, no. 297).

The painting is now in the Museo de Bellas Artes, Buenos Aires. Another Sachs drawing shows the full-length figure and is a study for the painting now in the National Gallery of Scotland. A third drawing is in the Cleveland Museum; a fourth, which belonged to Mlle. Fèvre, is now in the collection of Sir Kenneth Clark. The last is inscribed in Degas' own hand "Chez Martelli 3 avril 79." The Buenos Aires and Edinburgh portraits were shown in the Salon of 1879, so drawings and paintings were done in the same year. Jean S. Boggs and Lamberto Vitali (see below) have cleared up the confusion about the sitter's identity. Diego Martelli (1833-96), a Florentine, interested in both the arts and letters, was a prominent member of the group that used to meet in the Caffè Michelangiolo and a friend of the painters known as the Macchiaioli. Degas probably knew him first in Florence and later in Paris, where Martelli also knew Corot, Millet, Daumier and Manet.

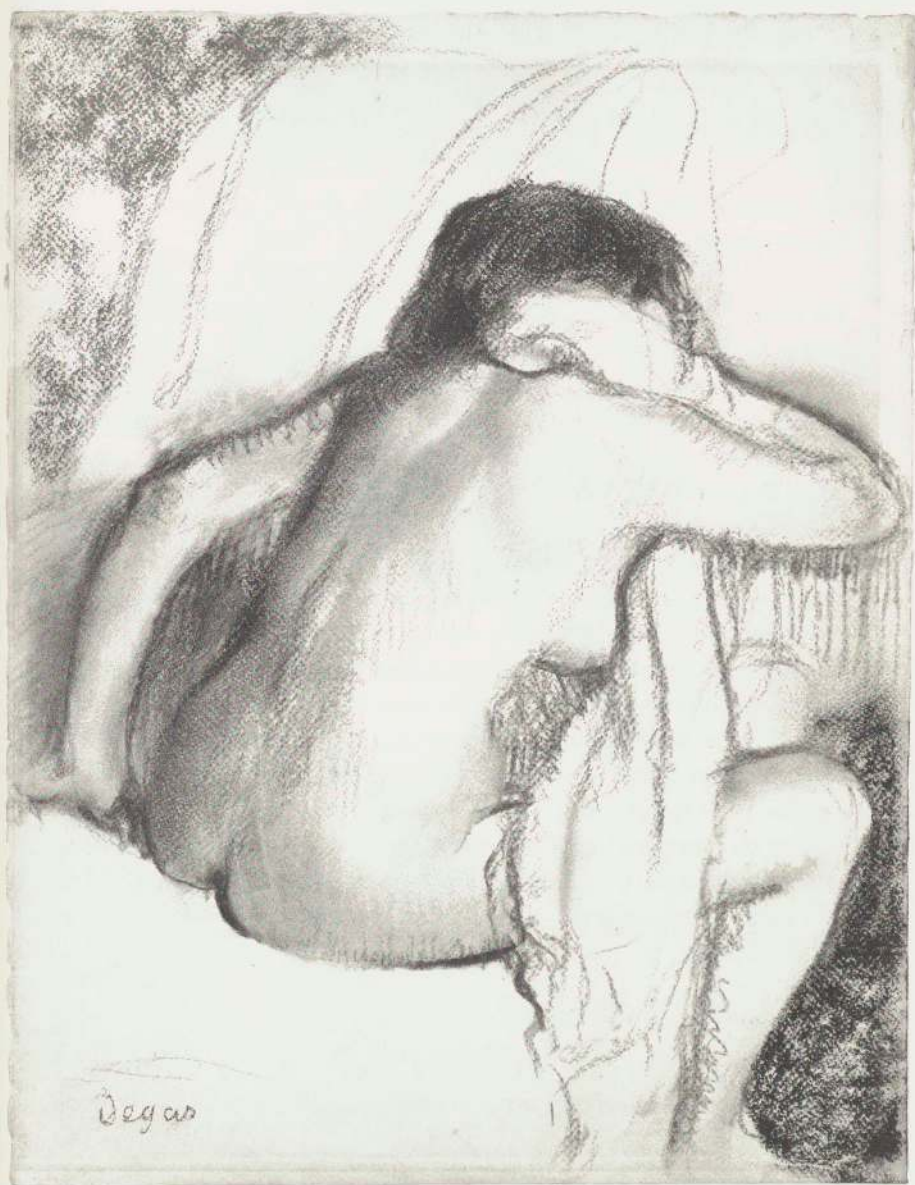

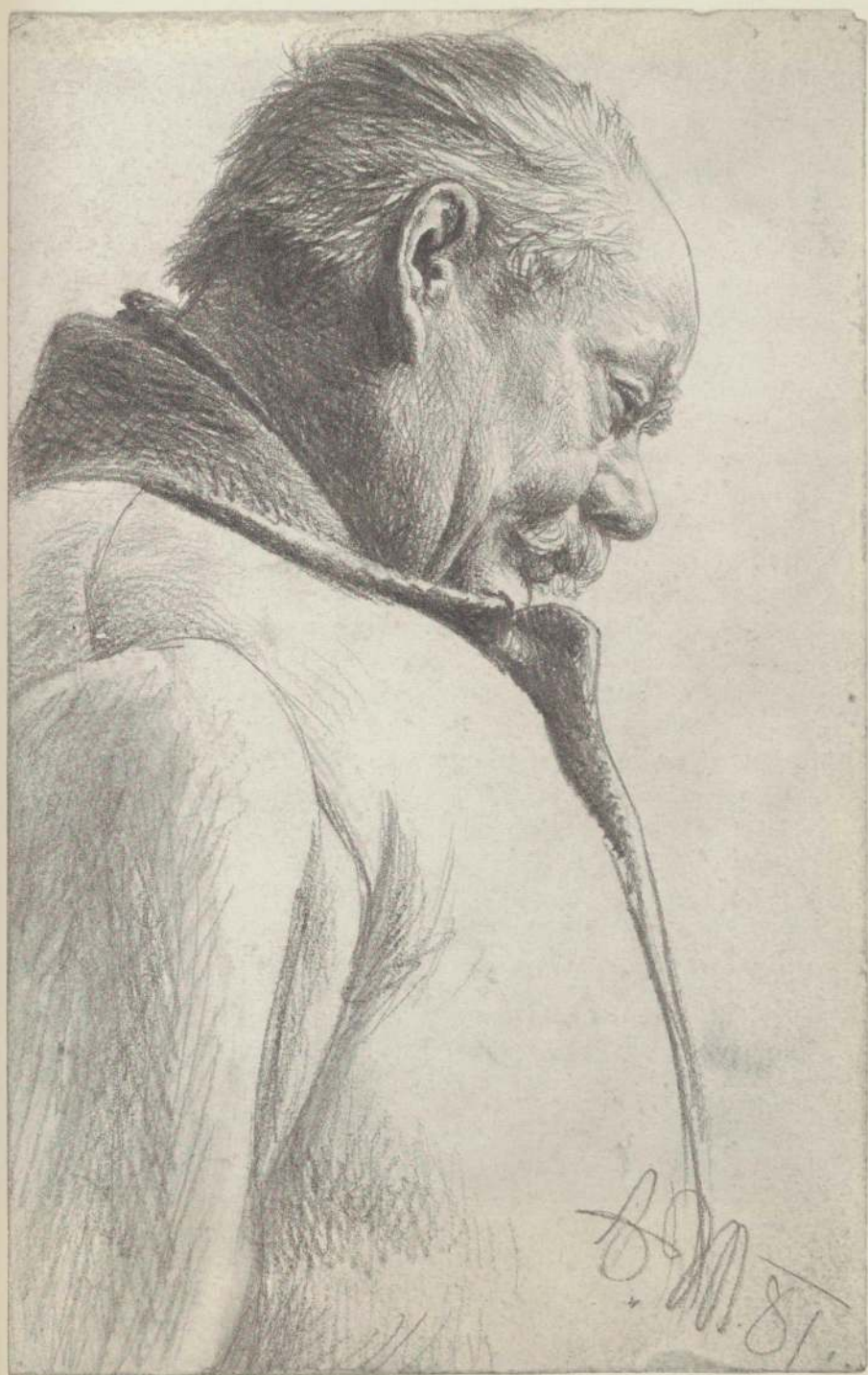

Two recent exhibitions of Menzel's drawings, a large and important one held in Berlin in 1955, and another in Bremen in 1963, have again brought the prolific nineteenth-century German draughtsman to public attention. In 1832, at the age of sixteen, Menzel became the chief support of his widowed mother, brother and sister, when he took over his father's lithography business. The habits of industry and accuracy, which he then developed, stood him in good stead throughout his long and productive life. Famous in his lifetime as an historical painter, he is more widely known today as a draughtsman of wide-ranging interests with a touch that is both bold and controlled. Many surviving sketches are highly detailed pencil studies, which show him examining and recording textures and the play of light and shadow with the same steady eye that he turned on himself in his self-portraits. This drawing, almost exactly the same size as many pages from the sketchbooks of the sixties through the eighties, may be an informal sketch of Bismarck, whose portrait Menzel had painted ten years earlier. The artist favored this particular pose. Many men and women are represented looking inward and downward. Menzel's left-handedness is not always as apparent as it is in the shading of this solid figure.

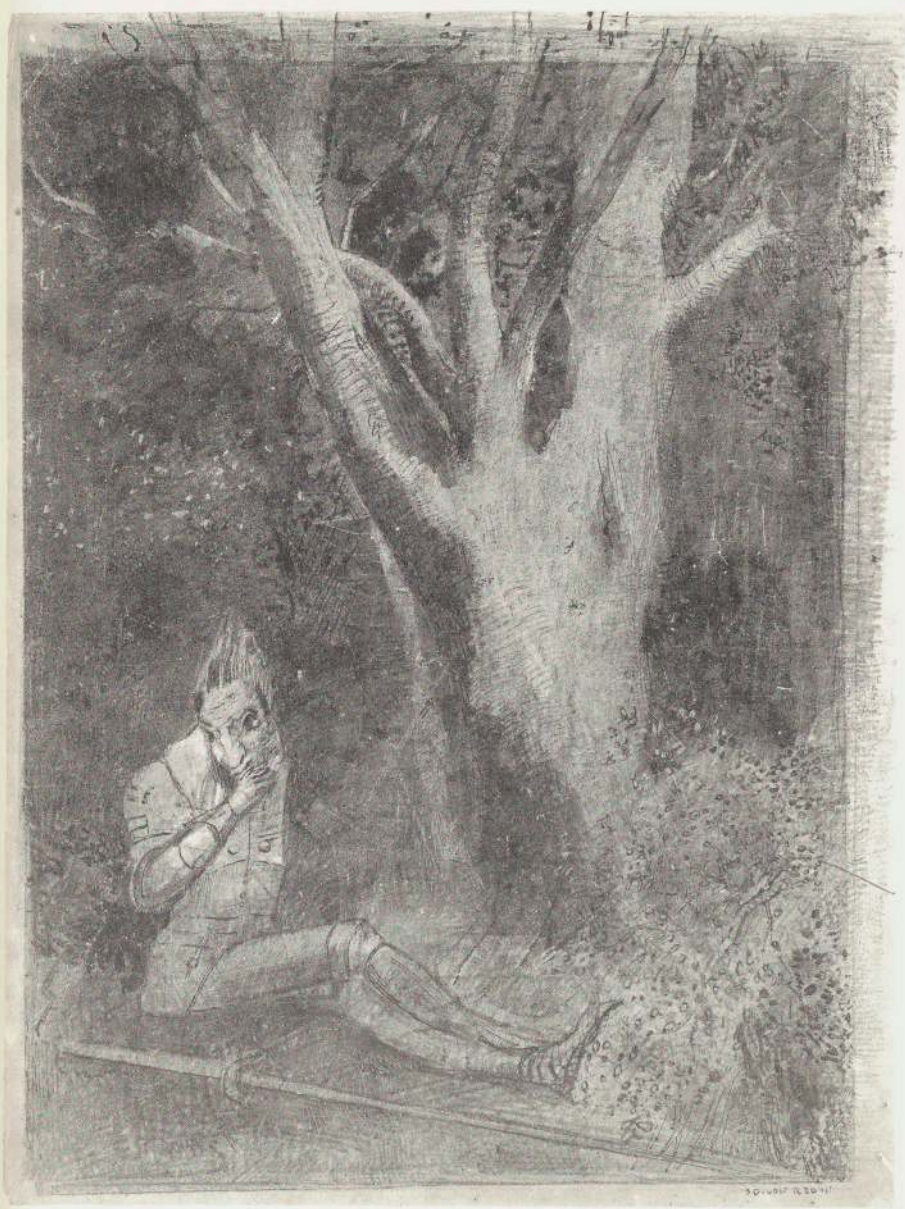
"Black is the most essential color," wrote Redon. "It conveys the very vitality of a being, his energy, his mind, something of his soul, the reflection of his sensitivity." This comment, cited by Mr. Sachs in his *Modern Prints and Drawings* (p. 55), suggests the spirit in which his *Don Quixote* can be appreciated. There is no single black. Instead Redon has built up an infinitely varied surface, playing off the accents of a pen line or delicate scraping against the dense shadows of black chalk and crayon. The result is a curiously iridescent form, appropriate to the haunting image of the knight and the tree. The subject is not documented; there is no reason, however, to doubt its traditional title, *Don Quixote*. Although undated, a stylistic comparison with Redon's lithographs suggests a date of ca. 1886. Sven Sandstrom, the author of *Le monde imaginaire d'Odilon Redon*, Lund, Sweden, 1955, suggested a date between 1885-90 with a reworking before 1895 (letter, May 15, 1955).

Concerning the quality of the drawing, there is no disagreement, but there is a divergence of opinion concerning its date. Leymarie, who considers it one of the most beautiful of Gauguin's drawings in its monumental simplicity and human radiance, dates it from Gauguin's last visit to Brittany in 1894, finding in its fullness of form and ease of style an echo of Gauguin's South Seas' experience. With this opinion E. Mongan agrees. John Rewald and Richard Field note the strong similarities to the figures in *Seaweed Gatherers*, Folkwang Museum, Essen, and the *Breton Girls* (Private Collection, Paris) and date it about 1889.

The drawing reveals clearly the influence of Steinlen, but it may be that Steinlen's influence reached Picasso through Ramón Casas. Casas, whom Picasso knew at the influential Barcelona café, Quatre Gats, encouraged Picasso and passed on to him the influence of the French draughtsmen (A. H. Barr, *Picasso*, p. 16). Casas was a prolific artist whose portrait drawings, which show the influence of both Steinlen and Lautrec, are reproduced in great number in the periodical *Pèl y Ploma*, which he edited from 1899-1903. It was in 1901 that Picasso discarded the Spanish custom of the double patronymic, so the drawing must predate that year. The model, who wears a long artist's smock and holds an open book almost as though it were a painter's palette, was in fact a writer and, like Picasso, a Paris resident.

The drawing is a study for the painting in the Göteborg Art Museum, Sweden. There is a pastel repeating the motif of mother and child, dated 1905, in an anonymous Swiss private collection. In the pastel the mother is nursing the child whose right hand is on her breast. She looks down tenderly in three-quarters view as here, not in profile as in the painting. John Richardson (visit 1958) was the first to suggest that the nude on the verso is a self-portrait. He noted its similarity to the *Self-Portrait* of 1901, still owned by the artist (Barr, p. 23). The drawing is at present and has been for some time the most popular drawing in the Fogg's collection.

Rivera arrived in Europe, on his second journey, in December, 1911. During the next few years he was in Paris on and off, alternately absorbed in the Paris scene and in painting away from Paris, in Madrid, Barcelona and Majorca. He was one of the few artists whose life and work was not completely disrupted by the war, but the cataclysm posed problems even for those not immediately involved. By 1918 Rivera's experiments with Cubism and Futurism were behind him. It was the year when Cézanne's influence was paramount, but it was also the year when he was studying the work of the old masters, David, Holbein and, one suspects here, even Ingres. For the time being his personal characteristics, above all his "Mexicanism," were submerged. A group of drawings dated 1918, like this one, show great exactitude, finesse and delicacy and a sentiment that is reflective and withdrawn. It was a style which was not sympathetic to him nor suitable for what he felt was his historic calling. In 1919 he "determined deliberately to kill everything in his own work which was not his own" (Jere Abbott, *Museum of Modern Art catalogue*, see below). He went off to Italy and there found the means of his liberation. We have been unable to identify Madame Fisher.

The drawing is a study for the painting *Lady Jean*, formerly in the Stephen Clark Collection and bequeathed by him to the Yale Art Gallery. The painting, one of Bellows' most beloved works, was painted at Woodstock, New York, in the summer of 1924, less than six months before the artist's death. The drawing must have preceded it by a very short time. All the members of the Bellows family liked to "dress up." One day that summer, Jean, the younger of the artist's two daughters, dressed up in a dress made about 1870 for a very small woman (Frances R. Nugent, *George Bellows*, New York, 1963, p. 33) given her by a southern lady "to wear to a party." Jean was then nine years old. Her father was so enchanted with her appearance that he painted her wearing the dress. A comparison of the figure in the drawing with that in the painting reveals only slight changes of detail.

In 1920 Grosz married Eva Louise Peter, and in 1926 their first son Peter was born. It was during this period of the mid-twenties that the acid satire of his earlier work was richly complemented by a series of family portraits, including the 1925 *Portrait of the Artist's Mother* and the studies of *Grandma Peter* done in 1926-27. Among the latter is this monumental drawing. The vigorous rhythm of his pencil line, softened by stumping, communicates an alertness and competence in his mother-in-law. It also harmonizes Grosz' formal interests both in subtleties of texture and massive form. This was the first drawing acquired by the Museum of Modern Art, given by Mr. Sachs only a few days after the museum had opened in October, 1929.

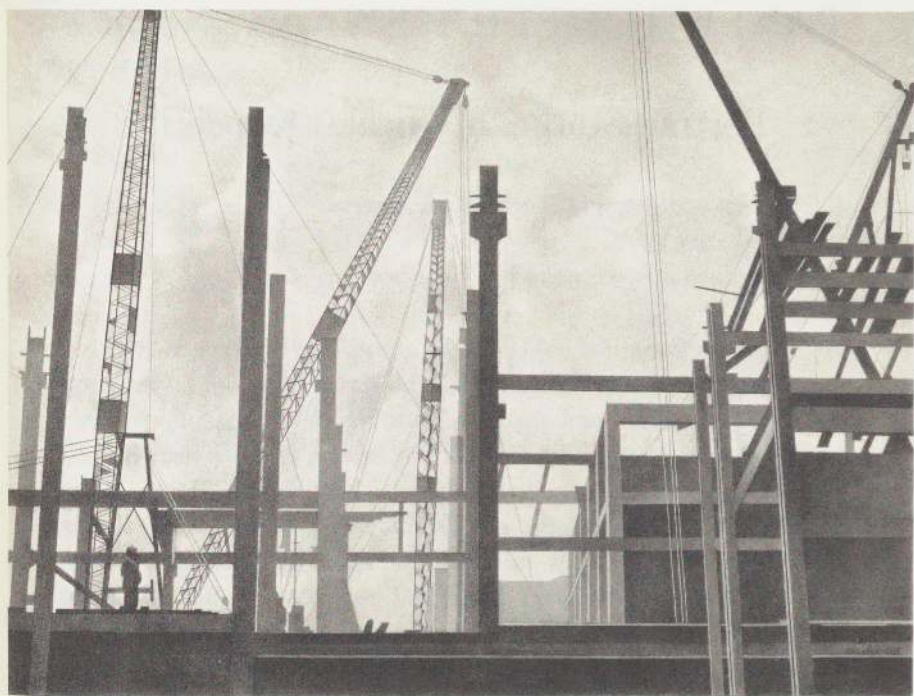

In a foreword to the exhibition of his work at the Museum of Modern Art in 1939, an exhibition in which this drawing was included, Charles Sheeler wrote, "From the casual portrayal of the momentary appearance of nature learned in art school, to the concept of a picture as having an underlying architectural structure to support the elements in nature which comprise the picture, was a long journey. . . ." He went on to compare his interest in photography and in painting, finding that the two interests were parallel, not competitive, "the painting being the result of a composite image and the photograph being the result of a single image." His first trip to Italy in 1909 (his third journey abroad) was a milestone, for he discovered in Giotto and Piero della Francesca that "a picture could be assembled arbitrarily with a concern for design" (Constance Rourke, see below). This he had not learned in Chase's studio. His work a little later as a photographer of houses for Philadelphia architects must have strengthened his interest in structure, as did his 1927 photographs of the Ford Plant at River Rouge. The easily overlooked figure at the left, once seen, immediately gives another dimension to these striking mechanical forms and their penetration of space. Not all the interest of the drawing lies in its formal values. A small tempera ($3\frac{3}{4} \times 5$ in.) with the same title was no. 99 of the Museum of Modern Art Exhibition (Mr. and Mrs. O'Donnell Iselin).

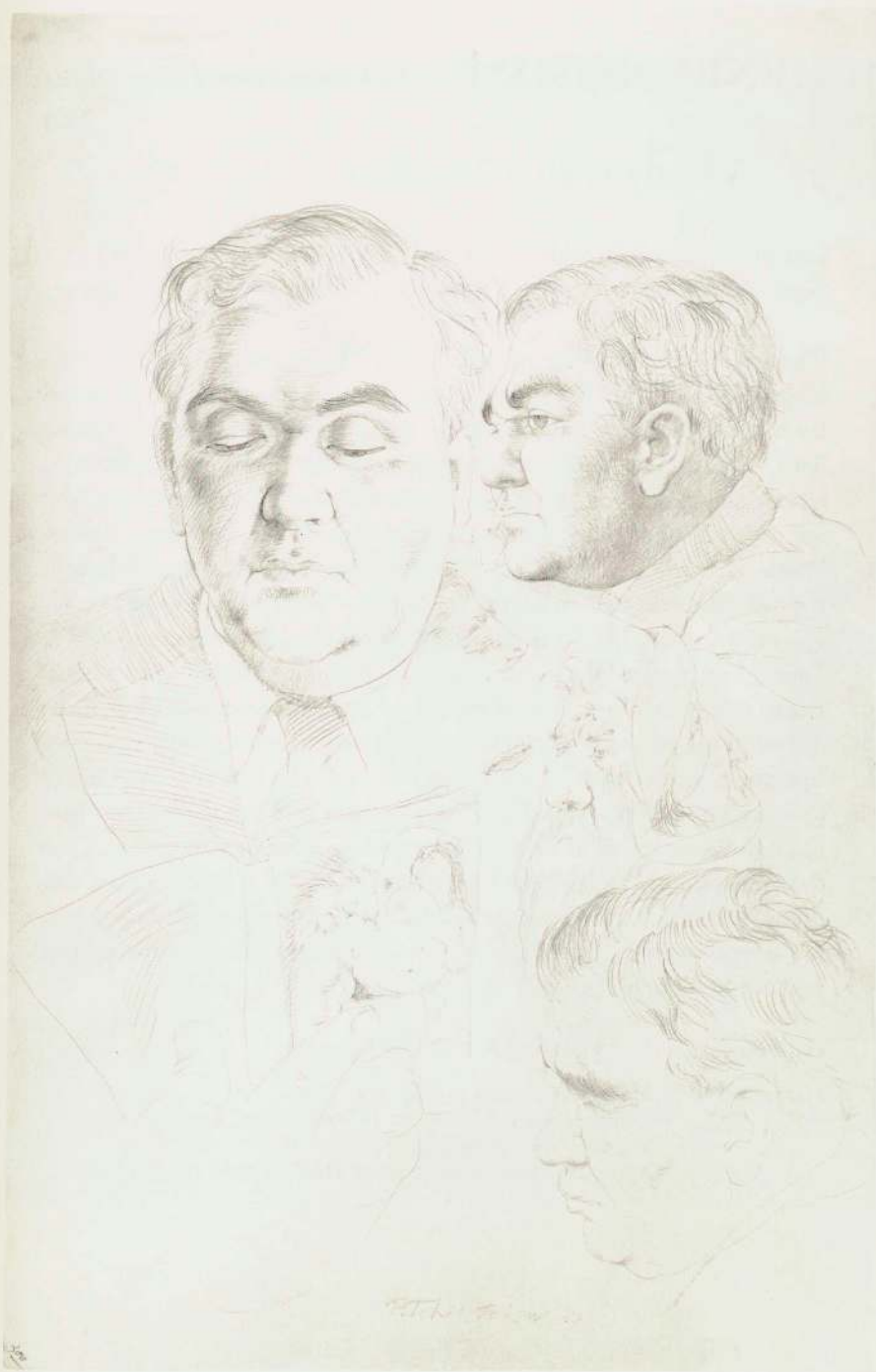

According to James Soby (*Tchelichew*, Museum of Modern Art, New York, 1942, pp. 28-29) the artist, while he was working on his important painting *Phenomena* and a series of portraits, developed a deep interest in the medium of silver point. This was in 1935 and the years immediately following. The portrait of Kopeikine, Kirstein records, was drawn in the spring of 1937 in the artist's studio. Kopeikine was a Russian pianist whom Tchelichew met in New York. The musician and the painter shared an interest in ballet, and both were friends of Georges Balanchine. Here are discernible the beginnings of Tchelichew's interest in the multiple image and in metamorphosis. The coat collar begins to turn into a porcupine and there is a Janus-like head between the profile view and the full face. Kirstein records that in addition to the separate drawings of Kopeikine's hands which he reproduces (pl. 10), Tchelichew also made drawings of him dressed as a child prodigy and in various operatic disguises. Other silver point portraits of him belong to Dr. Burrill B. Crohn and Edaldji Dinsha, both of New York.

The model for the drawing was Lydia Delectorskaya, the blue-eyed blonde Russian who, beginning in 1935, can be recognized as the model for many of Matisse's most successful paintings and drawings. R. Escholier (*Matisse*, New York, 1960, p. 155) wrote that "her plastic splendour, beauty and expression of face, intelligence and wit" constantly inspired the artist. Matisse made a series of drawings of her wearing a Balkan blouse. According to Alfred H. Barr (*Matisse*, New York, 1951, p. 223) she later became and remained the artist's "loyal secretary and buffer against intrusion." Matisse, in explaining his own drawings, wrote in *le Point* (July, 1939), "My line drawing is the purest and most direct translation of my emotion. Simplification of means allows that. But those drawings are more complete than they appear to some people who confuse them with a sketch. They generate light; looked at in a poor, or indirect light, they contain not only quality and sensibility, but also light and differences in values corresponding obviously to color ... the drawings are always preceded by studies made in a less vigorous medium ... it is not until I feel exhausted by that work, which may go on for several sessions, that I can with a clear mind give run to my pen without hesitation" (quoted by Escholier, p. 123).

On February 19, 1944, a statue of the Madonna and Child carved by Henry Moore in green Hornton stone was unveiled in St. Matthew's Church, Northampton, England. The imaginative vicar of St. Matthew's, Canon Hussey, had commissioned the work because he had been struck by Moore's drawings of mothers protecting their children in the London air-raid shelters. He had found the drawings extraordinarily moving in both spiritual and human terms. Moore had explored the theme of the mother and child throughout his career, sometimes with an almost Cycladic simplicity (*Mother and Child*, 1931, Kearnly Collection), at others, as here, with a new monumentality of scale and concern for expressive gesture. "The Madonna and Child should have an austerity and a nobility and some touch of grandeur (even hieratic aloofness)," wrote Moore, "which is missing in the everyday 'Mother and Child' idea" (J. J. Sweeney, *Henry Moore*, Museum of Modern Art, New York, 1946, p. 81). The bold rhythms and massiveness of the Sachs drawing reflect his search for these qualities. The free pencil sketch on the verso suggests some of Moore's large bronze reclining figures.

The second title is that written below the wood engraving, with some color, which Shahn designed and Baskin engraved. Paul Sachs gave the print to the museum when he presented the drawing. Soby (see below) dates the drawing 1950. There is also a serigraph which differs slightly from the drawing. For the woodcut, the figure of the man and a large drawing of a wheat field (reproduced as end papers of Soby's book) were made into a single composition. Selden Rodman in his monograph on Ben Shahn (New York, 1951) introduces his subject thus: "To understand the imagery of an artist whose work extracts universal meanings from a real world, it is helpful to know everything that can be known about that artist. ..." When queried about the *Man Picking Wheat* (conversation, August 17, 1965), Ben Shahn said that when he, a city-bred person, went to live in Roosevelt, New Jersey, he looked at the countryside with new eyes. He added that he meant the gesture of the man picking the wheat to have a hieratic significance. Further conversation revealed long thoughts and memories. He spoke of his childhood in Russia and of his grandparents waiting for the harvest, and of a memory of his grandfather walking through a field of tall ripening grain, estimating the quality of the crop and the meaning of that estimate.

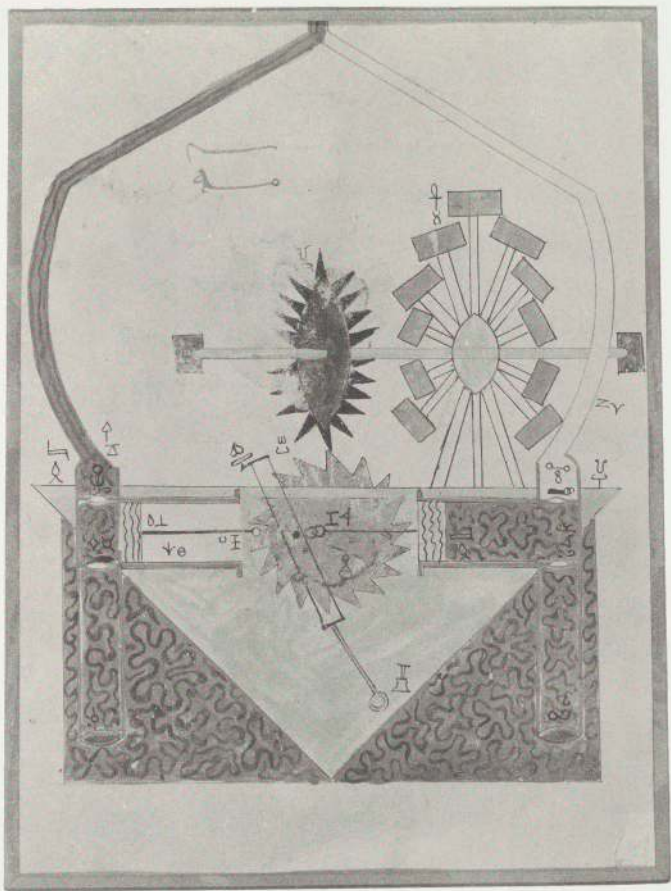

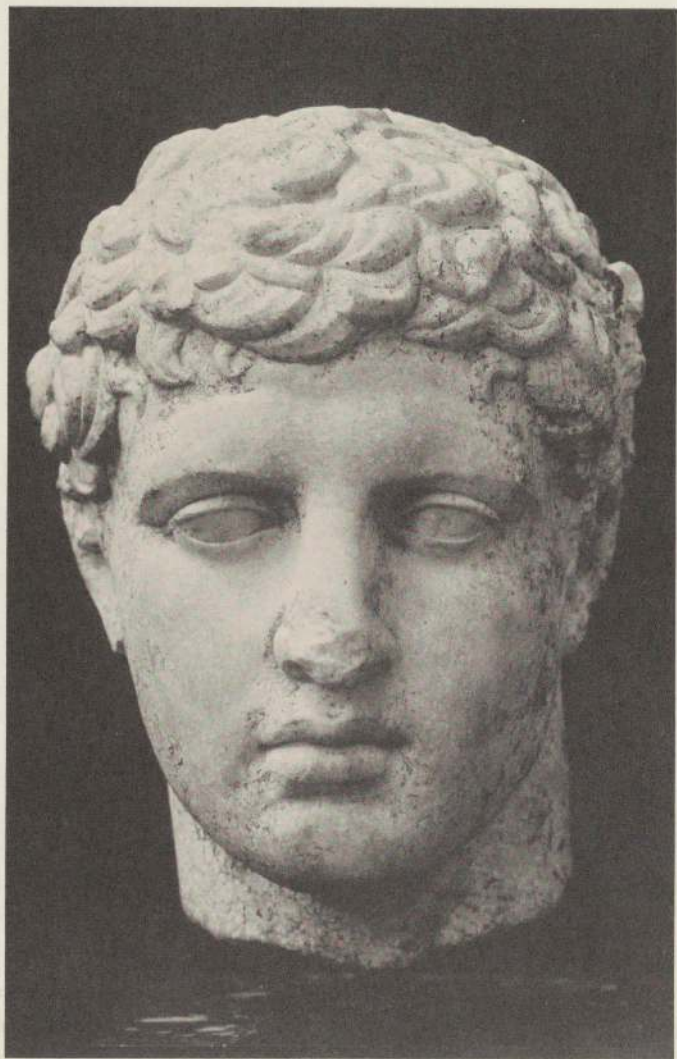

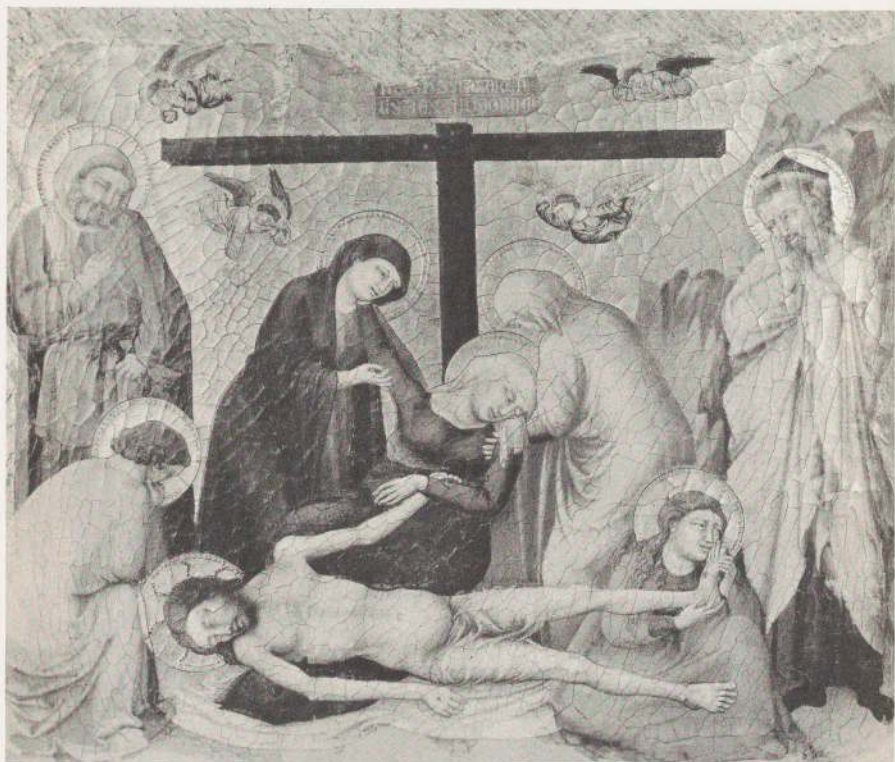

Grace Norton, one of Charles Eliot Norton's daughters, had been brought up in the house at Shady Hill. In her last years she became a great friend of Paul Sachs.

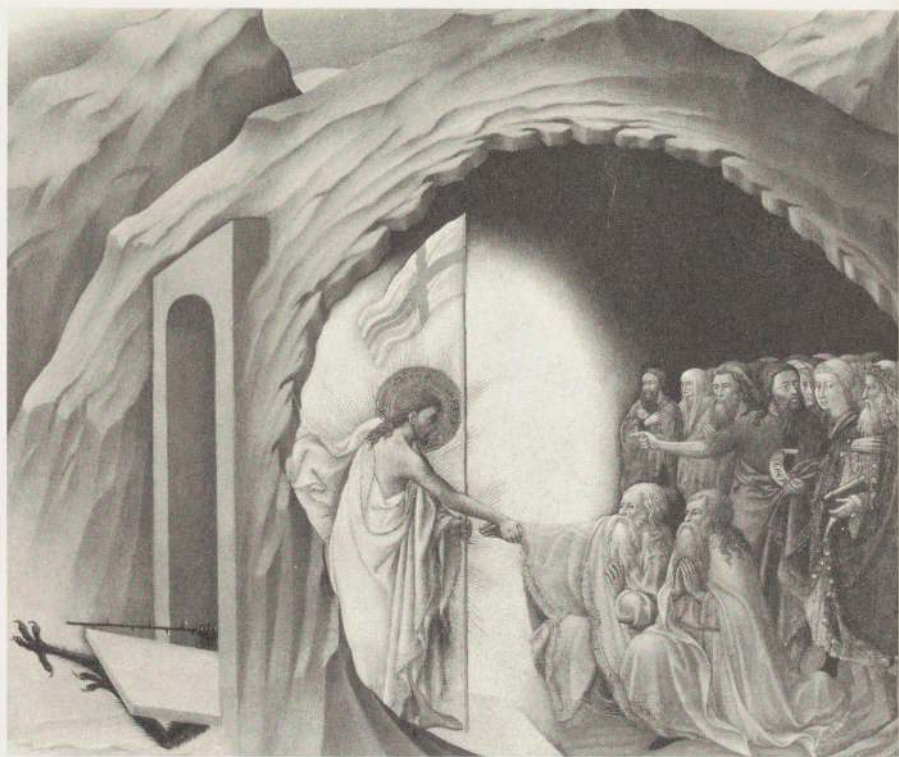

The painting was exhibited at the Royal Academy, London, in 1879. It then bore an attribution to Cavallini. Italy was about to declare war and the negotiations were somewhat agitated. In order to assure its purchase Mr. Sachs bought it himself. Twenty years later he presented it to the Fogg Museum in honor of Edward W. Forbes.

Sir Charles Robinson, who discovered these paintings in Madrid about 1870, was director of the South Kensington Museum and, from 1882 until the death of Victoria, "Surveyor of the Queen's Pictures." He traveled widely on the continent, purchasing paintings and drawings, many of which he later sold. Lugt describes him as "one of the most sagacious and erudite connoisseurs of his epoch." No other certain work by Juan de Burgos is known. Each panel is in its original elaborate gold frame.

A panel in the Louvre, the *Sermon of a Saint*, is the key picture around which scholars have reconstructed the *oeuvre* of an anonymous Flemish painter active during the last quarter of the fifteenth century. His name refers to the towers of St. Gudule, the Cathedral of Brussels, which rise in the background of the painting. The attribution of our panel to the Master of St. Gudule was originally suggested by Friedrich Winkler. First loaned to the Fogg Art Museum in 1926, the painting was given to Harvard in 1950 and subsequently transferred to the Busch-Reisinger Museum. In a letter to his father from Venice, February 13, 1852, Ruskin described the painting. "Of course it is very slight and a mere sketch, or it would fetch more money (Ruskin was hoping his father would reimburse him for his expenditure), but a grand thing—about a quarter of an hour of the man's handling altogether, but the suggestion of a complete picture." (*Stones of Venice*, III, in *The Works of Ruskin*, ed. E. T. Cook and A. Wedderburn, London, 1904, XI, p. 376.) When Ruskin acquired it, it was attributed to Veronese, an attribution he quickly changed. Paul Sachs recommended the painting to *his* father. It was then thought to represent Diana, but the late Dr. Suida identified it as one of a series of allegories of the Virtues. This one would be an Allegory of Fidelity.

The painting is among the most beautiful of several classical *Holy Families* by Poussin. It was painted when landscape was becoming of increasing importance to the artist. The bath which the Madonna prepares for the Child is a symbol of purification and redemption. Paul Sachs urged his father, with success, to purchase the painting when it arrived in New York. It was presented to the Fogg Museum by Mrs. Samuel Sachs in memory of her husband, Samuel Sachs.

Stella, who commissioned the picture, was a painter and art dealer in Rome. The painting is an elaborate allegory at several levels of meaning. Mercury brings the newborn Bacchus down from Jupiter to be raised by the nymphs who recline near a grotto which is entwined with vine leaves and filled with jars of wine. The god Pan plays on his pipes in a grove above. At the right Narcissus dies of self-love and the spurned Echo turns slowly to stone. Life is contrasted with death, fertility with sterility and the divine with the human. Paul Sachs bought the painting for his father in London in 1923.

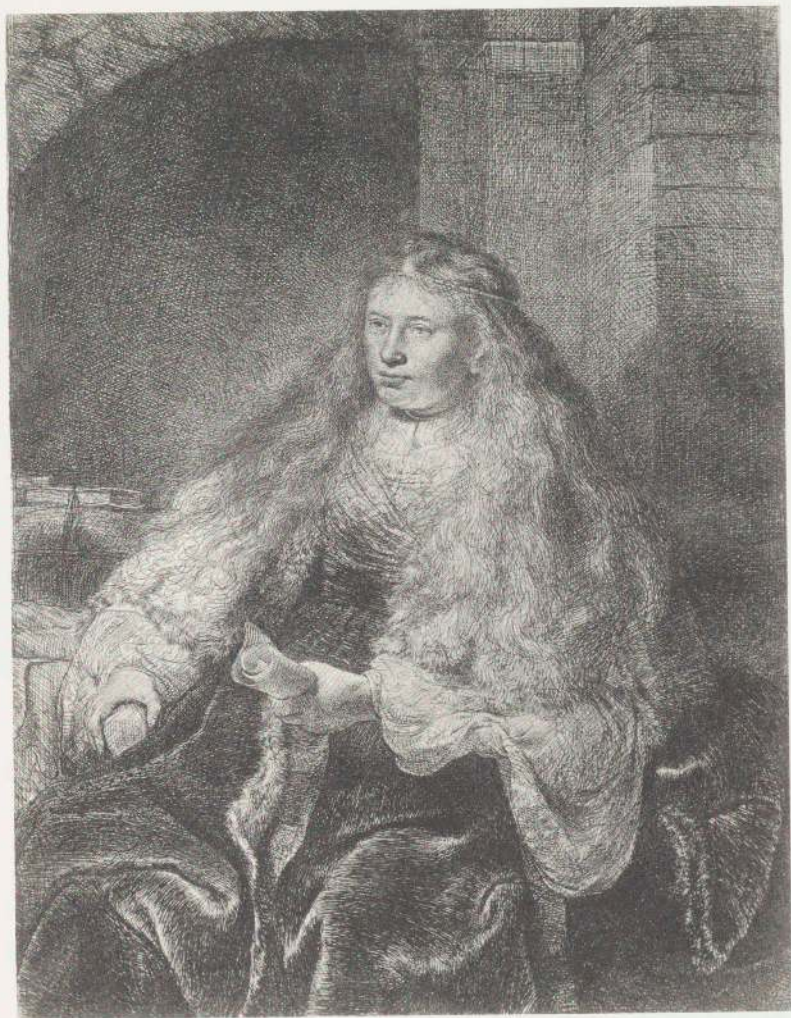

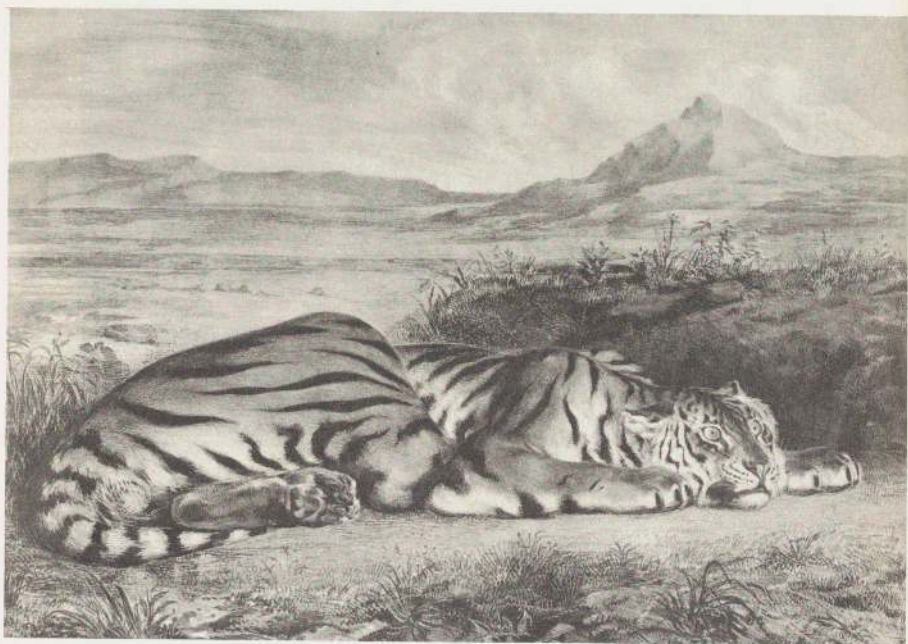

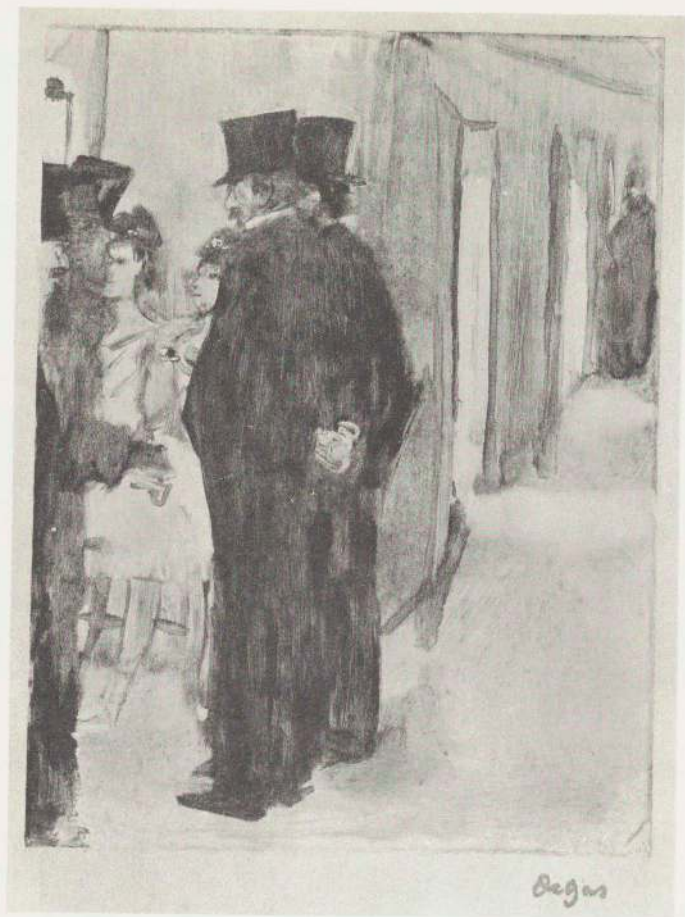

For his composition he borrowed from Rembrandt's *Self-Portrait at a Window*. The print was made in Rome in the winter of 1856-1857.

The monotypes of Degas have a distinct, subtle quality. For a long time they were ignored by print collectors because they did not fit into the traditional categories of graphic techniques. Because of his astute understanding of the artist, Paul Sachs recognized, long before most other collectors, their unique quality. This scene was planned as one of the illustrations for a book, *La Famille Cardinal*, by Degas' friend Ludovic Halévy. It was Degas' only attempt to make book illustrations and the project was abandoned before completion. The illustrations which Degas prepared have, however, been reproduced in a modern edition (Paris, Auguste Blaizot et Fils, 1939).

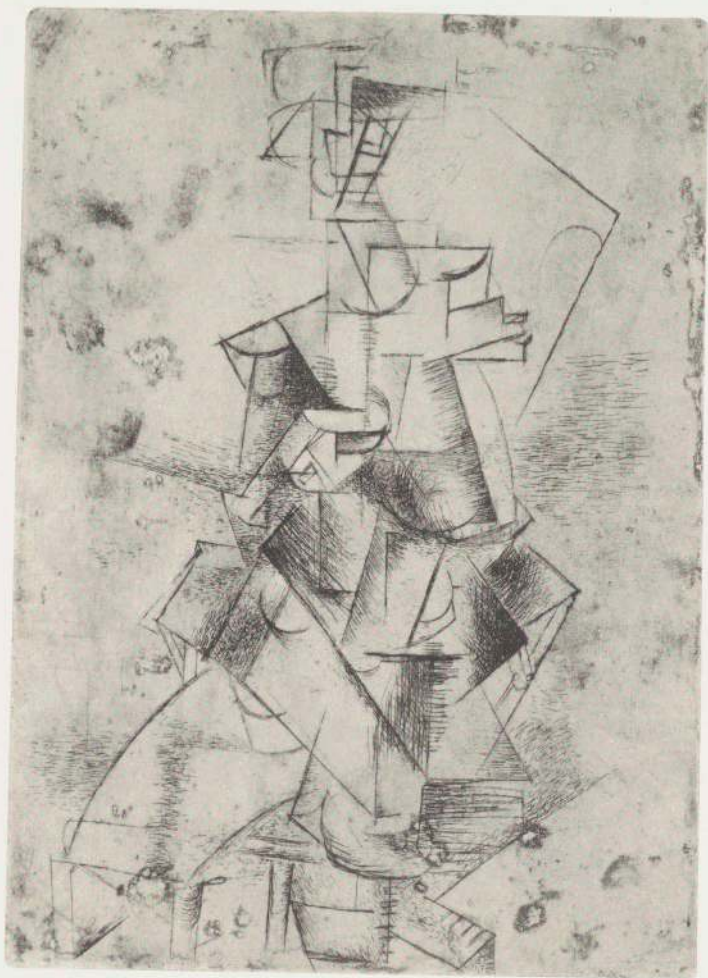

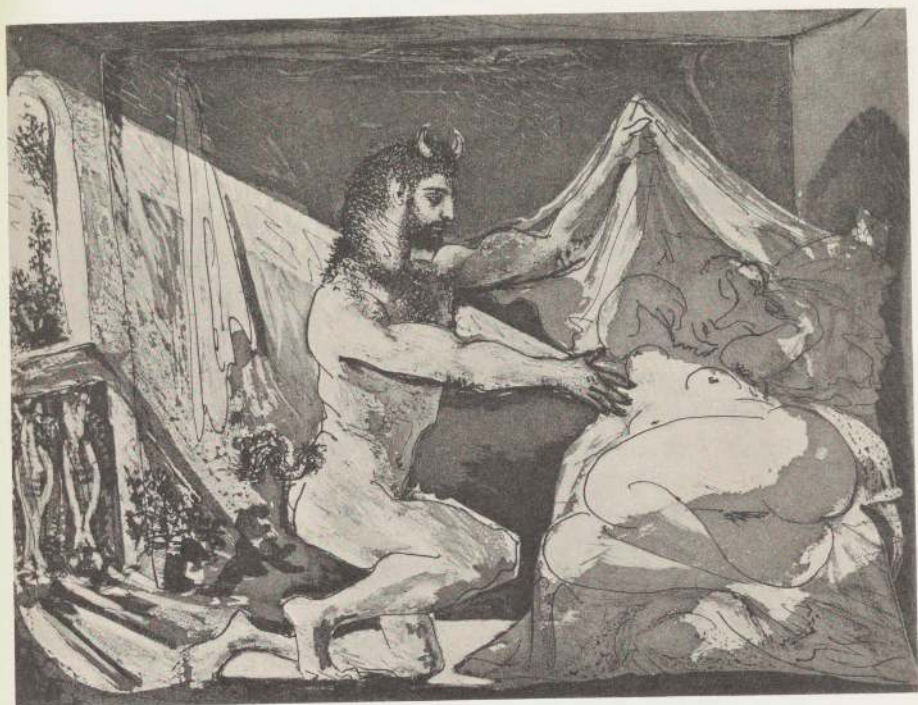

Prints

It has proved impossible in a catalogue this size to give the title, medium and acquisition number of the two thousand and twelve prints given or bequeathed by Paul J. Sachs. However, to give some idea of his range as a print collector, we have compiled two lists, one according to national schools and the other according to the medium in which each print was executed.

Not infrequently Mr. Sachs made a gift in conjunction with one or two friends. These gifts we have not included, but we would like to call attention to the size and interest of one such gift. In 1938, Mr. Sachs and his close friend of many years, W. G. Russell Allen, an equally passionate and enlightened print collector, presented to the Fogg Museum Print Room five hundred and sixty-seven French eighteenth-century engravings.

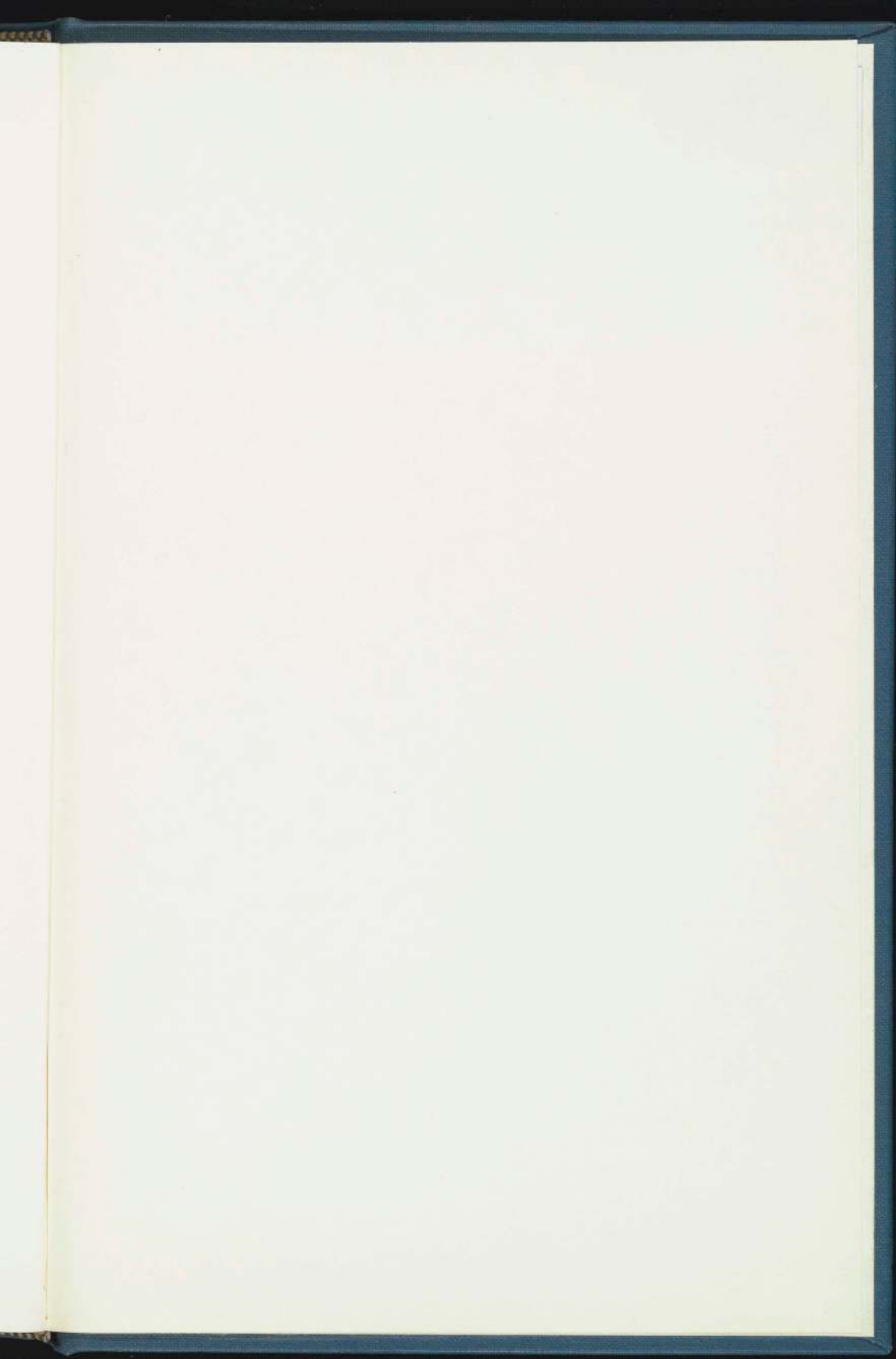
