The International Council of The Museum of Modern Art, now holding its annual Fall meeting in New York City (November 9-10-11), is a membership organization of approximately 140 community leaders and art patrons from the United States and abroad. It was formed in 1953 to help create good will and understanding among the world's peoples by encouraging the exchange of art exhibitions. Since 1957, the Council has sponsored the Museum's international exchange program of the visual arts, the largest in America.

Walter Dowling, former United States Ambassador to Bonn, now living in Paris, is Chairman of the Council. The newly-elected President of the Council is Mrs. Donald B. Straus of New York City, a Trustee of the Museum since 1959. Honorary members include Mrs. John F. Kennedy, The Honorable C. Douglas Dillon, Senator William Fulbright, André Malraux and Sir Herbert Read.

Since 1953 the Museum has sent abroad more than 80 exhibitions, which have been seen in more than 60 countries. Among those exhibitions currently traveling under the auspices of The International Council is THE NEW JAPANESE PAINTING AND SCULPTURE, which opened at the San Francisco Museum of Art last Spring and will tour seven museums in the United States, including The Museum of Modern Art, during the next two years. Other shows include: an American watercolor exhibition and bronze sketches by Jacques Lipchitz now touring Australia; MODERN SCULPTURE: U.S.A. on view in Germany; DRAWINGS BY ARSHILE GORKY on exhibition in Portugal; LETTERING BY MODERN ARTISTS and ROADS both circulating throughout South America; and STEICHEN THE PHOTOGRAPHER in Italy.

The International Council is also responsible for sending 24 collections of works of art -- borrowed from museums, galleries and private individuals -- to United States embassies in Europe, Asia, Latin America and Africa. Such collections now enhance the United States embassies in Ethiopia, Iceland, France, Cameroon, Nigeria, Italy, Germany, India, Mexico and Finland.

The Council has its headquarters at The Museum of Modern Art in New York where the Department of Circulating Exhibitions organizes the exhibitions sponsored by the Council. Its twice a year membership meetings have been held in recent years in Washington, Houston, Detroit, Cleveland and, last Spring, in San Francisco and Los Angeles.
