THE MUSEUM OF MODERN ART PLANS BENEFIT

A SPRING FESTIVAL will be held in the Sculpture Garden of The Museum of Modern Art on Wednesday evening, June 9, for the benefit of the Museum's program and for the Children's Art Carnival in Harlem which the Museum sponsors.

The Festival will feature a preview of the Frei Otto exhibition tent erected on the Upper Terrace, where guests will dance to the music of Slim Hyatt and Allene Callender. Floodlights will illuminate the translucent tent suspended from a 50' mast, as well as the sculptures and fountains, trees and pools. Refreshments will be served.

A feature of the evening will be the premiere of a new film, "Five," a documentary which includes interviews with Romare Bearden and Richard Hunt, whose one-man shows are currently on view at the Museum, and Betty Blayton Taylor, Director of the Children's Art Carnival. Barbara Chase Riboud, a sculptor who lives in Paris, and Charles White from California are also in the film which was commissioned by Seagram Distillers Company.

The Museum's general program, the main beneficiary of the Festival, faces a severe financial crisis. Despite stringent economics, the anticipated deficit for this year is more than one million dollars, because of reduced income from endowments and rising costs.

The entire ground floor of the Museum will be open for the Festival. Exhibitions on view, in addition to the Hunt and Bearden shows, are <u>Technics and Creativity: Selections</u> from Gemini G.E.L. and Projects: Keith Sonnier, an experimental work.

Dancing will be under the Frei Otto translucent tent, which is suspended from masts and anchored by steel cables. It was designed by a former associate of the well-known German architect, and made with funds donated by Farbwerke Hoechst and its American Subsidiary, Hyston Fibers.
