Mr. Young studied last year under Stockhausen, one of the originators of "electronic music." Mr. Riley has been a pupil of Robert Erikson. Both men are in the last year of the Master's program in music at the University of California and both have received Hertz Music Fellowships. They have been working with Ann Halprin on an experimental combination of sound and dance improvisation. Mr. De Marini is a Master's candidate in art at the University.

This evening is not intended as a time in which an audience will be in receipt of a message from messengers called musicians. It will rather be a time in which all of us, musicians and audience, will be involved in the search for a new auditory experience, a purposeful improvisation based on knowledge of the past used in a contemporary manner.

Writing of such evenings as this, John Cage said in the April issue of Art News that these sounds do not imply contempt for society. Rather they assume each person, whether he knows it or not, to be noble and able to experience gifts with generosity and respect.
