Many kind regards to all the friends also.

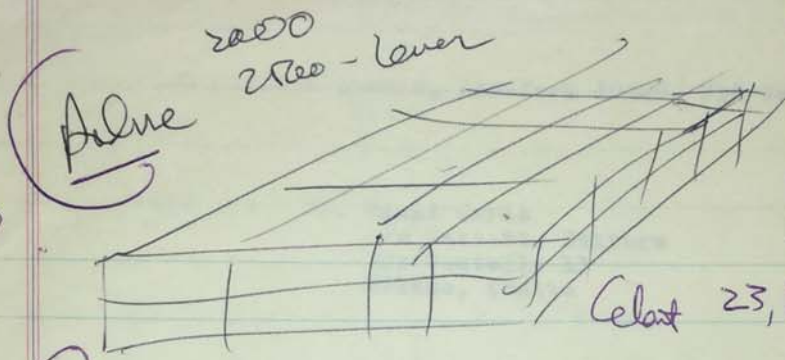
